FATAL TRAFFIC CRASH - NEXT OF KIN NOTIFIED - THESE ARE TROOP D'S 46TH, 47TH, 48TH, AND 49TH FATALITIES FOR 2023. CRASH OCCURRED AS VEHICLE 1 CROSSED CENTER LINE AND STRUCK VEHICLE 2, VEHICLE 3, VEHICLE 4, VEHICLE 5, AND VEHICLE 6. AFTER IMPACT, VEHICLE 1 TRAVELED OFF THE WEST SIDE OF THE ROADWAY AND CAME TO A REST IN THE DITCH. VEHICLES 2-6 OVERTURNED, EJECTING THE DRIVERS AND OCCUPANTS, AND CAME TO A FINAL REST OFF THE EAST SIDE OF THE ROADWAY. VEHICLE 4 THEN CAUGHT FIRE. OCCUPANT 2, DRIVER 4, OCCUPANT 4, AND DRIVER 6 WERE PRONOUNCED DECEASED AT THE SCENE AT 1155 HOURS BY LAWRENCE COUNTY CORONER SCOTT LAKIN. ASSISTED BY CPL T.A. HADLOCK #789, TPR S.D.
