COUNT 1

Beginning on an unknown date, and continuing through March 5, 2025, said date being approximate, in Newton County, in the Western District of Missouri, and elsewhere, the defendant, **JOHN HENRY JOSEPH II**, knowing that he was an unlawful user of a controlled substance as defined in 21 U.S.C. § 802, knowingly possessed one or more firearms, including, but not limited to a Heckler & Koch, model P30SK, 9mm caliber pistol, bearing serial number 214-006789, which had been transported in interstate commerce, all in violation of Title 18, United States Code, Sections 922(g)(3) and 924(a)(8).
