STATEMENT OF PROBABLE CAUSE

I, Ofc. Kaitlin Rundel, a Patrol Officer with the Aurora-Marionville Police Department, Lawrence County, Missouri, being duly sworn and on my oath, do state, aver, and affirm as follows:

I believe there is probable cause for the issuance of a warrant for Nardo, Jacob Earl; DOB: 01-27-1996, [REDACTED] following offense(s)

1. The crime occurred on 06-06-2023 at 1753 hrs in Lawrence County.
2. The victim in this case is Bogle, Krista and State of Missouri.

On 06-06-2023, at approximately 1753 hrs, I, Ofc. K. Rundel was headed into work when I heard dispatch give a call to the day shift officer about a stolen vehicle out of Joplin, MO and an off duty Joplin officer was behind the vehicle passing Hogtide on US 60, at Lawrence 1200. I was at US 60 and Lawrence 2210, going over the bridge. I pulled over to the shoulder and informed dispatch that I was on duty and was in position to intercept the vehicle. The black Dodge Avenger, MO plate: E6GH2Z passed me and I turned around on the vehicle. Dispatch confirmed that the vehicle was stolen out of Joplin (NIC: V535090451) on 06-05-2023 and the driver was presumed to be armed with a gun.

I asked the other responding officers for their location and they stated that they were close. I made a traffic stop on the vehicle. The Avenger pulled over to the side of the road at US 60 and Lawrence 2210. The driver, Jacob Nardo and passenger, [REDACTED] started to move around in the vehicle. The other officers had not made it to my location yet, and Nardo put the vehicle into drive and pulled back onto the highway at a high rate of speed. I activated my emergency equipment and pursued Nardo and Fonteneau into Marionville City limits.

Upon approaching US 60 and Western, the Avengers hazard lights came on and they braked hard. The Avenger made a left turn onto Western and accelerated at a high rate of speed. I looked at my speedometer, I was going 85 MPH, and the Avenger was still pulling away from me. As we approached Wester and HWY ZZ, the Avenger did not brake for the stop sign and jumped HWY ZZ. Almost causing the vehicle to wreck. The Avenger continued down Western and entered the county on Lawrence 1230. The Avenger continued to accelerate and was able to make distance between us. The Avenger turned westbound on Lawrence 2170, without stopping at the stop sign. The Avenger continued down 2170. Then the Avenger took the curve and went onto Lawrence 1225. I was able to stay behind the vehicle until road conditions caused me to slow down. I lost sight of the vehicle, but could still see dust flying through the air. I was able to locate the Avenger flipped over on Lawrence 2160, between Lawrence 1220 and 1217.

I approached the vehicle, but the driver's door was open and no one was in the vehicle. Officers searched the area and were able to locate Nardo and Fonteneau two fields over, in the tree line. Ofc. Hern transported Nardo to Mercy Hospital-Aurora to be cleared for confinement. Nardo started talking to Ofc. Hern at the hospital, so he read Nardo is Miranda Rights and Nardo admitted to driving the vehicle and fleeing because he thought he had warrants for his arrest. Nardo had a confirmed Probation and Parole Violation warrant issued for his arrest on 05-06-2023 and a misdemeanor Failure to Appear-DUI warrant out of Christian County, issued on 05-15-2023. Nardo also had four non-extraditable warrants issued on 06-14-2023, out of Joplin Police Department.

This law enforcement officer requests a warrant pursuant of Missouri Supreme Court Rule 22.03. It is upon belief that:


