2. The facts supporting this belief are as follows:
Montana Scott Lansaw committed the offenses of Assault 1st Degree and Armed
Criminal Action by knowingly shooting a firearm into an occupied residence while
an adult was walking into the residence and another was inside.

On 10/13/2025 Montana Scott Lansaw was at the Hillside Estates during which time
he engaged in an argument with V3, and WI4. During the argument, V3 struck Mr.
Lansaw with a chair and began walking toward the house making a statement about
getting a gun. Mr. Lansaw then drew a firearm from a bag carried on his person
and began firing at the house where V3 walked. At the time of Mr. Lansaw firing
at the house V3 and V2 were inside the home.

Deputies with the Newton County Sheriff's Office processed the scene during
which time several holes resembling bullet holes were witnessed and photographed
both inside and outside the home located at ██████████. Additionally, a green
single sling bag was located near Mr. Lansaw's home on a porch that was attached
to an unoccupied residence. Upon photographing and seizing the bag, a pistol
and identification for Mr. Lansaw was located inside the bag.

Mr. Lansaw surrendered to law enforcement in front of the Hillside Estates
trailer park and was taken into custody. Mr. Lansaw was transported to the
Newton County jail without incident and after being advised of his Miranda
Rights Mr. Lansaw made no statements and requested an attorney.
