2. The facts supporting this belief are as follows: On January 11, 2026, I observed a brown Buick Regal with Missouri license plates LB2-R1U that appeared to had expired in June 2025 on College Road. It appeared the vehicle was trying to avoid me. I had dispatch check the license plate in MULES and was advised the vehicle belonged to a subject on [REDACTED]. I responded to the address and made contact with the registered owner who stated that he had sold the car to a [REDACTED] and that they had not returned the license plates when requested.

During the course of the investigation, I had contacted Benton County Sheriff's Office. They advised that [REDACTED] was a white male, approximately 5'8 or 9, 130 to 140 pounds with tattoos on his extremities. I was aware that Inbody had tattoos on his hands and matched the description provided. I was also aware that Inbody was carrying a black back pack. I then observed Inbody and [REDACTED] was walking south on U.S. Highway 71 approaching State line liquor at 22176 U.S. Highway 71. I responded to that location and made contact with Inbody.

When advised of the reason for the contact, he was asked and stated he did not have identification on him. He did provide a name of [REDACTED] with a DOB of [REDACTED]. I had dispatch check [REDACTED] in MULES and was advised that he had a warrant from Arkansas Probation and

Parole. Inbody was secured in properly adjusted wrist restraints, a black back pack was removed from his back. He then stated that he had provided us with his brother's information. During a pat down, a wallet was discovered in his back pocket with Inbody's Arkansas issued identification card inside. A check of Inbody in MULES showed a Tennessee Probation and Parole warrant.

Inbody was verbally advised of his Miranda Rights. He stated he understood. He was asked that prior to transporting the backpack with him to jail, I asked to search it for weapons or contraband to prevent them from being entered in the jail. Inbody stated that anything found in the bag was not his. He stated that he had borrowed the backpack from someone and that anything that was in there was not his.

A search of the bag revealed a glass pipe with burnt residue and a white crystalline substance that, based on my training and experience I believe to be methamphetamine. I then observed a large quantity of a white crystalline substance in numerous bags that, based on my training and experience I believe to be methamphetamine. A Nartec methamphetamine field tester and tested positive for methamphetamine.

The substance was seized and transported to the McDonald County Sheriff's Office where it was weighed with a total weight of 115.1 grams obtained.
