INFORMATION

COMES NOW the State of Kansas, by Kurt C. Benecke, Cherokee County Attorney, upon information and belief, and gives the court to understand and be informed as follows:

COUNT 1 AGGRAVATED INDECENT LIBERTIES WITH A CHILD

That on or about February 6, 2022, in Cherokee County, Kansas, DAVID A JUSTICE did then and there unlawfully and feloniously cause a child to engage in lewd fondling or touching of the person of either the child or the offender, with a child who was 14 or more years of age but less than 16 years of age, to-wit: Confidential Victim, who did not consent thereto, with the intent to arouse or satisfy the sexual desires of the offender, the child, or both, a severity level 4 person felony, in violation of K.S.A. 21-5506(b)(2)(B) & (c)(2)(B).

Penalty Range: From a minimum of 38 months to a maximum of 172 months in prison and/or a fine of up to \$300,000 and 36 months of post-release supervision, pursuant to K.S.A. 21-6804, 21-6807, 21-6611(a)(2), & 22-3717(d)(1)(A), and amendments thereto.

COUNT 2 PROMOTING OBSCENITY TO MINORS

That on or about February 6, 2022, in Cherokee County, Kansas, DAVID A JUSTICE did unlawfully and recklessly manufacture, mail, transmit, publish, distribute, present, exhibit or advertise any obscene material or obscene device,, and a recipient of the obscene material or obscene device, or a member of the audience of an obscene performance is a child under the age of 18 years, to wit: Confidential Victim, a class A nonperson misdemeanor, in violation of K.S.A. 21-6401(b) & (c)(2)(A).

Penalty Range: From up to one year in the county jail and/or a fine of up to \$2,500, pursuant to K.S.A. 21-6602(a)(1) & 21-6611(b)(1), and amendments thereto.

COUNT 3 AGGRAVATED INDECENT LIBERTIES WITH A CHILD

That on or between May 1, 2022 and August 31, 2022, in Cherokee County, Kansas, DAVID A JUSTICE did unlawfully and feloniously engage in lewd fondling or touching of the person of either the child or the offender, with a child who was 14 or more years of age but less than 16 years of age, to-wit: Confidential Victim, who did not consent thereto, with the intent to arouse or satisfy the sexual desires of the offender, the child, or both, a severity level 4 person felony, in violation of K.S.A. 21-5506(b)(2)(A) & (c)(2)(B).

Penalty Range: From a minimum of 38 months to a maximum of 172 months in prison and/or a fine of up to \$300,000 and 36 months of post-release supervision, pursuant to K.S.A. 21-6804, 21-6807, 21-6611(a)(2), & 22-3717(d)(1)(A), and amendments thereto.

COUNT 4 INDECENT SOLICITATION OF A CHILD

That on or between May 1, 2022 and August 31, 2022, in Cherokee County, Kansas, DAVID A JUSTICE did unlawfully and feloniously entice, command, invite, persuade, or attempt to persuade a child 14 or more years of age, but less than 16 years of age, to-wit: Confidential Victim, to commit or to submit to an unlawful sexual act, as defined in K.S.A. 21-5501(d), as amended, to-wit: rape, a severity level 6 person felony, in violation of K.S.A. 21-5508(a)(1) & (c)(1).

Penalty Range: From a minimum of 17 months to a maximum of 46 months in prison and/or a fine of up to \$100,000 and 24 months of post-release supervision, pursuant to K.S.A. 21-6804, 21-6807, 21-6611(a)(3), & 22-3717(d)(1)(B), and amendments thereto.

COUNT 5 PROMOTING OBSCENITY TO MINORS

That on or between May 1, 2022 and August 31, 2022, in Cherokee County, Kansas, DAVID A JUSTICE did unlawfully and recklessly manufacture, mail, transmit, publish, distribute, present, exhibit or advertise any obscene material or obscene device, and a recipient of the obscene material or obscene device, or a member of the audience of an

obscene performance is a child under the age of 18 years, to wit: Confidential Victim, a class A nonperson misdemeanor, in violation of K.S.A. 21-6401(b) & (c)(2)(A).

Penalty Range: From up to one year in the county jail and/or a fine of up to \$2,500, pursuant to K.S.A. 21-6602(a)(1) & 21-6611(b)(1), and amendments thereto.
