PROBABLE CAUSE STATEMENT

1. I have probable cause to believe that on 03/16/2024, at

committed one or more criminal offense(s):

2. The facts supporting this belief are as follows:
I watched a video taped forensic interview with V1. V1 disclosed that when she was fourteen years old in the summer of 2021, she had sexual intercourse with Jacob Oakes a then thirty-seven-year-old male. V1 disclosed that her mother left her in the care of Jacob Oakes and was gone seeking medical treatment for one of her siblings. V1 disclosed that Jacob Oakes called her into his bedroom located in rural Neosho MO in Newton County. V1 disclosed that Jacob Oakes started kissing her and they took their clothing off. V1 disclosed that they got into bed, and he put his penis inside of her "vadge". V1 circled on an anatomical drawing that the "vadge" was her vagina and the penis was his penis. V1 disclosed that after the sexual intercourse was over, she slept in Jacob Oakes' bed with him the rest of the night. V1 disclosed that this has happened several times since then including at least one time in 2024. V1 disclosed that every time Jacob Oakes would have sex with her it would be either in his house or on his property.

I spoke to V1's mother and she told me that in the summertime of 2021 she did leave V1 with Jacob Oakes so she could take another child for a medical treatment.

I have made several attempts to get a statement from Jacob Oakes and he will not meet with me to get a statement from him.

I have talked to two separate witnesses that told me that V1 was on the phone with Jacob Oakes and the phone was on speaker. Both witnesses told me that they heard Jacob Oaks tell V1 that if she came back to him that he would stop the "sexual stuff".

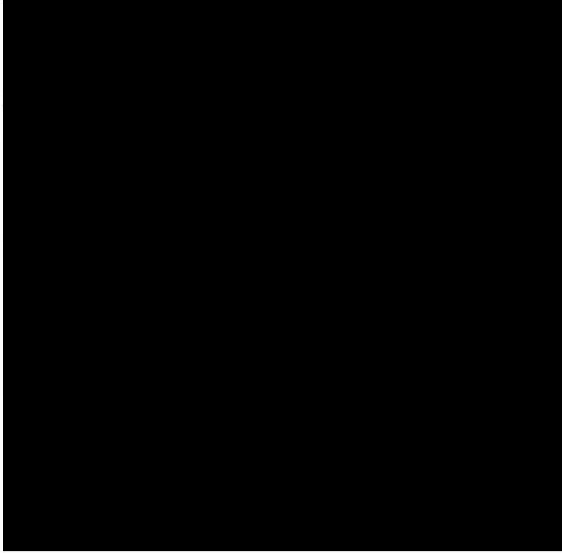
