



STATEMENT OF PROBABLE CAUSE

I, Sergeant Nathan Deherrera, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on 2/26/2026 at 25320 Maple Road, Webb City Missouri, Payne, Ryan William, a White Male (suspect description) committed one or more criminal offense(s) of:

RSMO 570.030 Stealing (\$750 or more)

2. The facts supporting this belief are as follows:
On 02/26/2026 I, Sergeant Nathan Deherrera #371, responded to the area of SW 80th road and State Line Road in Barton County Missouri for a stolen trailer. The trailer, a 20 foot home made goose neck style trailer, had been located at 25320 Maple Road in Jasper County. Due to previous issues with the trailer being messed with, Jasper County Detectives had placed a GPS tracker on the trailer with the owner's consent. At 0458 hours on 02/26/2026 I was advised by Detectives the trailer's GPS was moving. While locating the vehicle, I was provided consistent updates with the trailers direction of travel. The trailer was located shortly after entering into Barton County attached to a 2014 Ford F250 (KS LP#799PRJ). A Felony stop was conducted and driver, Ryan Payne, exited the vehicle and was detained. After being advised his Miranda Rights, Ryan initially advised he had been in the process of purchasing the vehicle. After being informed about the tracker, Ryan advised he had stolen the trailer and had not purchased it. The value of the trailer is estimated to be \$800.00. The owner advised he would pursue charges.

3. MISDEMEANORS AND FELONIES: (If seeking a warrant) I am requesting issuance of an arrest warrant based on the following:

[X] I believe that the defendant will not appear in court in response to a criminal summons because: Ryan has been previously convicted of stealing a motor vehicle out of Barton County Missouri. Ryan was placed on probation for that charge in 2006 but later had his probation revoked, showing a history of failin to adhere to instructions set by the court.

[X] I believe the defendant poses a danger to [] a crime victim / [X] the community or to any other person because:
Ryan has a long documented history of resisting arrest and felony stealing.
