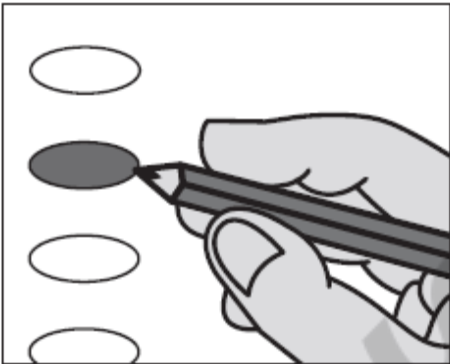

Fort Scott Question Submitted

Shall the following be adopted?

Shall the City of Fort Scott, Kansas be authorized to impose a one-half percent (0.5%) City-wide retailers' sales tax (the "Sales Tax"), the proceeds of which shall be used for the purpose of financing the following costs and related expenditures: (a) 80% of the proceeds for street improvements, sidewalks, bike lanes, and curb and gutter, and (b) 10% of the proceeds for Parks and community facilities, and (c) 10% of the proceeds for Public Safety

With the collection of the Sales Tax to commence on 7/1/2026; and to expire Ten (10) years after its commencement; all pursuant to the provisions of K.S.A. 12-187 et seq., as amended?
