COMPLAINT/INFORMATION

LABETTE, KANSAS

Alan Brereton, of lawful age, being first duly sworn on oath, for complaint against the above shown defendant, alleges and states:

COUNT 1

That on or about October 22, 2024, in Labette County, State of Kansas, Charles Levi Miller, did then and there unlawfully distribute a quantity of marijuana weighing less than 25 grams. In violation of K.S.A. 21-5705(a)(4), Distribution of marijuana, a drug severity level 4 felony. (Penalty Range: 14 to 51 months imprisonment in the custody of the Secretary of Corrections; a fine not to exceed \$300,000.00; and 24 months post-release supervision. K.S.A. 21-6805, K.S.A. 21-6611, and K.S.A. 22-3717, and amendments thereto.)

In violation of K.S.A. 21-5705(a)(4), Distribution of marijuana, a drug severity level 4 felony.

COUNT 2

That on or about October 22, 2024, in Labette County, State of Kansas, Charles Levi Miller, then and there being present did unlawfully and knowingly possess a firearm, having previously been convicted of a felony under article 57 of chapter 21 of the Kansas Statutes, Annotated, and amendments thereto, and less than eight years have elapsed since Charles Levi Miller satisfied the sentence imposed or the terms of any diversion agreement for such crime, or was discharged from probation, a community correctional services program, parole, postrelease supervision, conditional release or a suspended sentence. In violation of K.S.A. 21-6304(a)(3), Criminal possession of a firearm by a convicted felon, a severity level 8 nonperson felony. (Penalty Range: 7 to 23 months imprisonment in the custody of the Secretary of Corrections; a fine not to exceed \$100,000.00; and 12 months post-release supervision. K.S.A. 21-6804, K.S.A. 21-6611, and K.S.A. 22-3717, and amendments thereto.)

In violation of K.S.A. 21-6304(a)(3), Criminal possession of a firearm by a convicted felon, a severity level 8 nonperson felony.

COUNT 3

That on or about October 22, 2024, in Labette County, State of Kansas, Charles Levi Miller, did then and there unlawfully and recklessly cause or permit a child under the age of eighteen (18) years, to-wit: N.M. (YOB: 2021), to be placed in a situation in which the child's life, body or health is injured or endangered, to-wit: unsafely discharging a firearm in close proximity to the child. In violation of K.S.A. 21-5601(b)(1), Aggravated endangering a child, a severity level 9 person felony. (Penalty Range: 5 to 17 months imprisonment in the custody of the Secretary of Corrections; a fine not to exceed \$100,000.00; and 12 months post-release supervision. K.S.A. 21-6804, K.S.A. 21-6611, and K.S.A. 22-3717, and amendments thereto.)

In violation of K.S.A. 21-5601(b)(1), Aggravated endangering a child, a severity level 9 person felony.

COUNT 4

That on or about October 22, 2024, in Labette County, State of Kansas, Charles Levi Miller, did then and there unlawfully and recklessly cause or permit a child under the age of eighteen (18) years, to-wit: W.G. (YOB: 2007), to be placed in a situation in which the child's life, body or health is injured or endangered, to-wit: unsafely discharging a firearm in close proximity to the child. In violation of K.S.A. 21-5601(b)(1), Aggravated endangering a child, a severity level 9 person felony. (Penalty Range: 5 to 17 months imprisonment in the custody of the Secretary of Corrections; a fine not to exceed \$100,000.00; and 12 months post-release supervision. K.S.A. 21-6804, K.S.A. 21-6611, and K.S.A. 22-3717, and amendments thereto.)

In violation of K.S.A. 21-5601(b)(1), Aggravated endangering a child, a severity level 9 person felony.

COUNT 5

That on or about October 22, 2024, in Labette County, State of Kansas, Charles Levi Miller, did then and there unlawfully, and recklessly discharge a firearm, within or into the corporate limits of the City of Parsons, Kansas. In violation of K.S.A. 21-6308a(a), Unlawful discharge of a firearm in a city, a class B nonperson misdemeanor. (Penalty: Up to six months in the county jail; and a fine not to exceed \$1500.00. K.S.A. 21-6602, and K.S.A. 21-6611, and amendments thereto.)

In violation of K.S.A. 21-6308a(a), Unlawful discharge of a firearm in a city, a class B nonperson misdemeanor.
