1. I have probable cause to believe that on 2/152025 (offense date), in Joplin, Jasper County, Missouri (offense location), (suspect name) Andrew Michael Reed, a black male, (suspect description) committed one or more criminal offense(s) of: Unlawful Use of Weapons (571.030), Possession of a firearm unlawful for certain persons (571.070), Property Damage in the 1st Degree (569.100). (State name of offense and statute number)

2. The facts supporting this belief are as follows:

On 2/15/2025 The Joplin Police Department responded to Joplin, Jasper County, Missouri in reference to gunshots. Upon arrival, officers located multiple casings. Witness 1 said he observed Reed shooting at him after Reed assaulted him in Joplin, Mo. Witness 2 said they saw a black male matching Reed's description running from the area with a gun in his hand, immediately after the gunshots. Witness 3 provided surveillance footage showing Reed stashing his pistol under a dumpster in the direction he ran. The pistol was recovered by the responding officers and it matched the caliber of shell casings located at the scene of the shooting. Reed was convicted of a felony in the Kansas Shawnee County District Court, 3rd Judicial District, in 2021. When Reed was shooting his gun, one of his bullets struck another building in Joplin, Jasper County, Missouri. They bullet went through a window that Victim 1 says will cost around \$1,000 to replace, due to its unusual location.
