In accordance with Chapter 115 of the Laws of Missouri, Section 46-6 of the JOPLIN CITY CODE, and the HOME RULE CHARTER of the City of Joplin, notice is hereby given that a General Municipal Election will be held in the City of Joplin, Missouri on Tuesday, April 2, 2024, for the purpose of electing three (3) General Council Members, two (2) to serve a term of four (4) years and one (1) to serve a term of two (2) years and one (1) Zone II Council member, to serve a term of four (4) years, and one (1) Zone III Council Member to serve a term of four (4) years. All voters of the City are permitted to vote for Zone positions, whether or not they reside in the particular zone from which the council member is being elected.

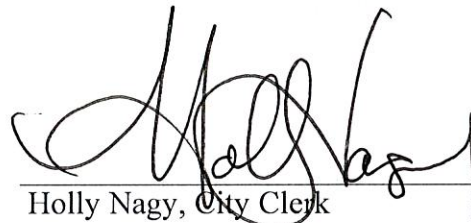

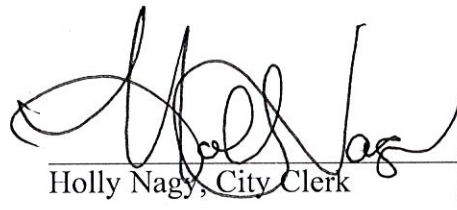

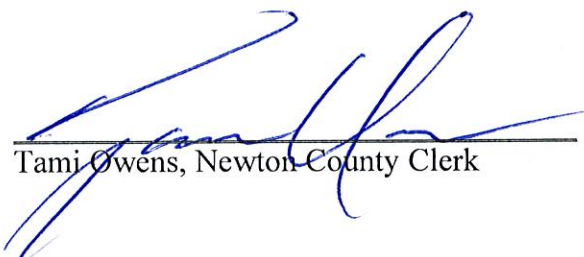
