I, Ofc Mosley, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

1. I have probable cause to believe that on 03/17/2026(offense date) at 3517 N Red Iron Dr (offense location), Bianca Crouch, (suspect name) a white female, (suspect description) committed one or more criminal offense(s) of : Animal abuse RSMO 578.012. . (State name of offense and statute number)

2. The facts supporting this belief are as follows:

On 03/17/2026 in the State of Missouri, in the County of Jasper, in the City of Webb City, I have reason to believe that Bianca Crouch committed the crime of Animal Abuse, when she intentionally, purposefully, and knowingly failed to provide adequate care to her dog Snoop (a male golden/brown medium size dog). Bianca failed to provide adequate care by dumping her dog in an industrial park located at 3517 N Red Iron Drive which resulted in the death of the dog. Upon my arrival I was notified by Cintas staff that Snoop was dumped in a field to the north of their faculty. Staff advised that Snoop was malnourished and couldn't stand. Upon observing Snoop, Snoop appeared to be starving with his ribs, spine, skull, and legs having no meaty flesh on them. Snoop was drooling, slow to react to stimulus, and could not walk on his own accord. When picking Snoop up to put in my patrol vehicle my fingers could feel through the webbing of his rib cage and into his chest and abdominal cavity. I was provided video footage from Hannah Birkinsha showing Bianca and Patrick removing the dog from their apartment located in Joplin Missouri. Upon contacting Bianca via cellphone Bianca advised that Snoop was sick and she didn't know what to do so they dumped Snoop alone in the industrial park. Upon the Humane Society of Joplin Missouri getting Snoop, they contacted Bianca and Bianca advised that Snoop was starved due to escaping her mothers house not from abuse.

3. MISDEMEANORS AND FELONIES: (If seeking a warrant) I am requesting issuance of an arrest warrant based on the following:

I believe that the defendant will not appear in court in response to a criminal summons because: Bianca has a history of not answering the door to law enforcement and not returning phone calls (State specific facts supporting your belief)

I believe that the defendant poses a danger to a crime victim / the community or to any other person because: Bianca Crouch failed to meet the adequate means of care for an animal under her care, custody, and control (State specific facts supporting your belief)
