2. The facts supporting this belief are as follows:
On 5/22/2025 Anthony S. Keller was driving southbound on Highway 59. While
driving, a roadrage incident occurred between him and the victim.

Keller became agitated and ran his vehicle into the side of the victims truck,
in an effort to push the victim's vehicle out of the way. The collision caused
damage to the pickup truck driven by the victim as well as Keller's vehicle.

While the vehicles continued southbound, Keller grabbed a Taurus .357 magnum
handgun from the center console, pointed it at the truck, and pulled the
trigger. Keller fired one gun shot at the white Chevrolet Silverado that was
being driven by the victim.

The gunshot penetrated the pickup trucks driver side window, penetrated the
