STATE OF OKLAHOMA, COUNTY OF OTTAWA:

I, Douglas S. Pewitt, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Ottawa and in the State of Oklahoma, **MICHAEL ANTHONY COOK III** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

**COUNT 1: FELONY DISCHARGING FIREARM INTO DWELLING ~ a FELONY**, on or about the 31st day of May, 2025, by unlawfully, willfully or intentionally discharging any firearm or other deadly weapon at or into any dwelling, or at any other building used for public or business purposes.

This crime is punishable by imprisonment for not less than 2 years nor more than 20 years.

**COUNT 2: SHOOTING WITH INTENT TO KILL ~ a FELONY**, on or about the 31st day of May, 2025, by without justifiable or excusable cause shoot Kolin Hall with a firearm, to-wit: firearm, the same being a deadly weapon loaded with gunpowder and shot, held in the hands of the said defendant and which he/she wrongfully and intentionally pointed, aimed and fired at the said Kolin Hall with the unlawful, wrongful, willful and felonious intent then and there on the part of said defendant to kill Kolin Hall.

This crime is punishable by imprisonment for up to life.

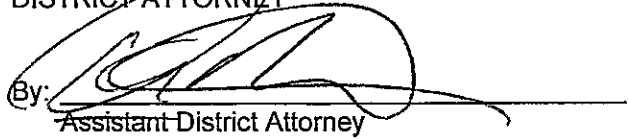
**COUNT 3: SHOOTING WITH INTENT TO KILL ~ a FELONY**, on or about the 31st day of May, 2025, by without justifiable or excusable cause shoot CJ Weaver with a firearm, to-wit: firearm, the same being a deadly weapon loaded with gunpowder and shot, held in the hands of the said defendant and which he/she wrongfully and intentionally pointed, aimed and fired at the said CJ Weaver with the unlawful, wrongful, willful and felonious intent then and there on the part of said defendant to kill CJ Weaver.

This crime is punishable by imprisonment for up to life.

**COUNT 4: FELONIOUSLY POINTING FIREARM ~ a FELONY**, on or about the 31st day of May, 2025, by willfully pointing a firearm at Miami Police Department and Miami Nation Police Department officers for the purpose of threatening or with the intention of discharging the firearm or with any malice or for injuring, either through physical injury or mental or emotional intimidation of for purposes of whimsy, humor or prank, or in anger or otherwise and for other than a lawful purpose, including an act of self-defense.

This crime is punishable by imprisonment for 1 to 10 years.

AFFIDAVIT FOR: **DETENTION**

**THE UNDERSIGNED UPON OATH DEPOSES AND STATES AS FOLLOWS TO WIT:**

**The following events took place in the city of Miami and the County Ottawa, State of Oklahoma**

On 5/31/25 at approximately 20:28 hours, Michael Anthony Cook III is at the Mia Bella restaurant located at 1220 N. Main St. in the city limits of Miami Oklahoma, located in the county of Ottawa. Cook is standing outside on the patio near the Northwest door. Several patrons inside the restaurant report seeing Cook, described as a black male wearing a black shirt. Mia Bella employee, Carson Holcom stated that he observed Cook on the patio and witnessed him shooting thru the patio glass door. Holcom reported that 6 employees were standing near the area where Cook had fired the pistol.

Prior to firing thru the door at Mia Bella's, a 7 brew employee, C.W (juvenile male) reported seeing Cook prior to the shooting. C.W stated he heard Cook yelling and when he looked over at Mia Bella's to see what was going on C.W stated that Cook pointed a black pistol at him. C.W stated he ran into a storage container at 7 Brew. C.W stated as he was exiting the storage container, he heard a gun shot and ran inside 7 Brew to notify staff.

It was around this time that several 911 calls were received by the Miami Police Department regarding the shooting. Several callers report seeing Cook walking near Arby's, across the street from Mia Bella.

Officer Kolin Hall was the first Miami Officer on scene. Officer Hall observed Cook in the parking lot of Arby's. Officer Hall gave Cook several commands telling him to drop the gun. Officer Hall's body camera footage shows Cook bending down, as if he was going to drop the pistol then quickly turning the pistol towards Officer Hall and firing several shots in his direction. Office Hall returned fire and began pursuing Cook on foot.

Cook ran to the south side of Arby's, eventually running to the parking lot of Autozone. Officer Eulitt (Miami Police Department) and Officer Weaver (Miami Nation Police Department) observe Cook near the Southwest

corner of Autozone parking lot near the dumpsters. Both Officer Eulitt and Officer Weaver give Cook several verbal commands to drop the gun. Cook continues walking away from Officers, ignoring commands to drop the pistol. Cook then begins traveling westbound on 13th Ave. NW and eventually runs to 1309 B St. NW.

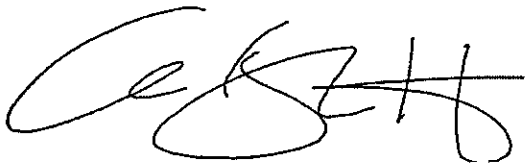
At this point several Officers have responded to this area. This includes Officer Eulitt, Officer Weaver, Sgt. Buchanan (Miami Police Dept.) and Officer Hall. At this location, body camera footage from the officer shows Officer's giving Cook several commands to drop the pistol. At this point Cook is sitting with his back near the south wall of the house, a gun can clearly be seen in the area between his legs and in his hand. Officer Weaver can be seen standing on the Southeast corner of the house, at which time Cook is observed pointing the firearm towards Officer Weaver and firing the pistol in his direction. Several Officers on scene return fire. Afterwards, Officers once again tell Cook to drop the gun, Cook picked up the pistol again and pointed it at the Officers. Officers return fire for the second time while on scene. After this occurred Officers were able to secure Cook's hands and place him in custody.

Cook was treated on scene for his injuries and later transported to Tulsa Oklahoma for further medical treatment.

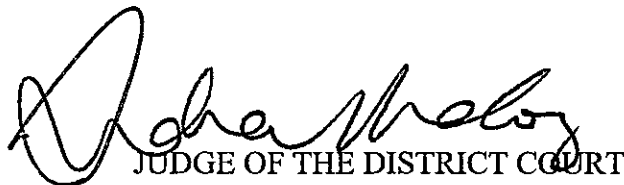

**STATE'S MOTION TO REDUCE BOND**

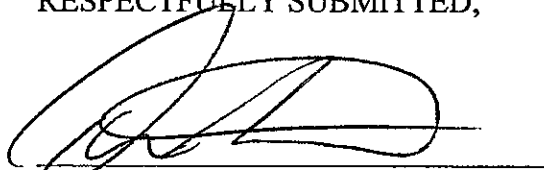
**COMES NOW**, the State of Oklahoma, by and through District Attorney, Douglas S. Pewitt, and moves this Court pursuant to 22 O.S. § 1101, to reduce bail in this matter. The State avers in support of this motion as follows:

1. Defendant, Michael Anthony Cook, III, was arrested, and probable cause determined for the crimes of shooting into a dwelling, two counts of shooting with the intent to kill and feloniously pointing a firearm. This includes crimes set forth in 57 O.S. § 571.
2. Defendant is hospitalized, with grave wounds, resulting from the incident precipitating his arrest.
3. Post incident investigation has indicated the Defendant has no prior criminal history and likely suffered from a mental illness.
4. The Defendant's family seeks to bond the Defendant out of custody. The Defendant is currently hospitalized by is attended, for observation purposes, by deputies of the Ottawa County Sheriff's office.

5. Upon consultation with the Sheriff and investigation agencies, there does not presently appear to be an ongoing threat to hospital personnel or the public from Defendant, as he is being treated for serious physical injury.
6. The State request bond be reduced to Ten Thousand Dollars (\$10,000.00) to enable the Defendant's family to assume direction of Defendant's physical and mental health care.
7. The investigation detective has determined there is not a prior pattern of abuse or history of violent crime with regard to the Defendant.

**WHEREFORE**, premises considered, the State requests bond be reduced in this matter.

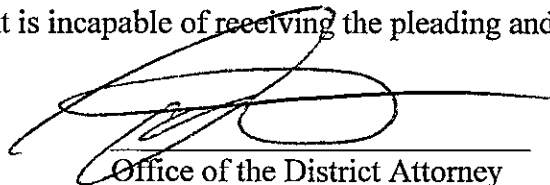
