THE GRAND JURY CHARGES:

<u>COUNT ONE</u> [18 U.S.C. §§ 1151 and 1153; 21 O.S. § 843.5(C)]

From on or about December 1, 2023, to on or about September 4, 2024, within Indian Country in the Northern District of Oklahoma, the defendant, **KEITH EDWARD ENYART**, an Indian responsible for the health, safety, and welfare of MV, a child under the age of 18 years known to the Grand Jury, willfully and maliciously failed and omitted to provide appropriate medical care, appropriate supervision, and appropriate caretakers, and to protect the child from harm and

threatened harm of which any reasonable and prudent person responsible for the child's health, safety, and welfare would be aware.

All in violation of Title 18, United States Code, Sections 1151 and 1153; Title 21, Oklahoma Statutes, Section 843.5(C).

COUNT TWO [18 U.S.C. §§ 1151 and 1153; 21 O.S. § 843.5(A)]

From on or about December 1, 2023, to on or about September 4, 2024, within Indian Country in the Northern District of Oklahoma, the defendant, **KEITH EDWARD ENYART**, an Indian responsible for the health, safety, and welfare of MV, a child under the age of 18 years known to the Grand Jury, willfully and maliciously harmed the health, safety, and welfare of MV.

All in violation of Title 18, United States Code, Sections 1151 and 1153; Title 21, Oklahoma Statutes, Section 843.5(A).

COUNT THREE [18 U.S.C. §§ 1151, 1152, and 113(a)(3)]

From on or about December 1, 2023, to on or about September 4, 2024, within

Indian Country in the Northern District of Oklahoma, the defendant, **JENNIFER BARGER ENYART**, a non-Indian, with intent to do bodily harm, assaulted MV, an

Indian known to the Grand Jury, with a dangerous weapon, by tasing MV's testicles.

All in violation of Title 18, United States Code, Sections 1151, 1152, and

113(a)(3).

COUNT FOUR [18 U.S.C. §§ 1151, 1152, and 13; 21 O.S. § 843.5(C)]

From on or about December 1, 2023, to on or about September 4, 2024, within Indian Country in the Northern District of Oklahoma, the defendant, **JENNIFER BARGER ENYART**, a non-Indian responsible for the health, safety, and welfare of MV, an Indian child under the age of 18 years known to the Grand Jury, willfully and maliciously failed and omitted to provide appropriate medical care, appropriate supervision, and appropriate caretakers, and to protect the child from harm and threatened harm of which any reasonable and prudent person responsible for the child's health, safety, and welfare would be aware.

All in violation of Title 18, United States Code, Sections 1151, 1152, and 13; Title 21, Oklahoma Statutes, Section 843.5(C).

COUNT FIVE [18 U.S.C. §§ 1151, 1152, and 13; 21 O.S. § 843.5(A)]

From on or about December 1, 2023, to on or about September 4, 2024, within Indian Country in the Northern District of Oklahoma, the defendant, **JENNIFER BARGER ENYART**, a non-Indian responsible for the health, safety, and welfare of MV, an Indian child under the age of 18 years known to the Grand Jury, willfully and maliciously harmed the health, safety, and welfare of MV.

All in violation of Title 18, United States Code, Sections 1151, 1152, and 13; Title 21, Oklahoma Statutes, Section 843.5(A).
