SPECIAL SCHOOL BOND ELECTION PROPOSITION K.I.D.S.

Shall the Board of Education of the New Franklin R-I School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Dollars (\$2,000,000) for the purpose of providing funds to complete tuck pointing at the High School; to repair the Elementary School and Middle School roofs; to replace heating, ventilation, and air conditioning (HVAC) at the Middle School; to renovate/upgrade the existing kitchen; to complete safety and facility upgrades Districtwide; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.8230 per one hundred dollars of assessed valuation of real and personal property.
