NEGLIGENT HOMICIDE (FELONY)

(Punishable by imprisonment in the state prison for a term not to exceed 20 years, a fine not to exceed \$50,000, or both)

The alleged facts constituting the offense are:

That the Defendant, KOBE DILLIAN CARR (born in August 2001; age 19), negligently caused the death of another human being, to wit: the Defendant negligently caused the death of K.S. (born in 2001; age 19) when the Defendant, without verifying whether a Smith and Wesson SD 9VE semi-automatic pistol was unloaded and/or whether there was a clip in the firearm, depressed the trigger of the firearm while it was pointed at K.S. and when trying to disassemble it; which caused the pistol to fire a live round that struck K.S. in the head and caused his death, all of which is a violation of Section 45-5-104, Montana Code Annotated, as well as being against the peace and dignity of the State of Montana.
