- b. The right to have witnesses testify on my behalf;

- e. The right to require my guilt to be proven beyond a reasonable doubt; and
- f. The right to challenge any evidence that has been illegally seized.

4. Waiver of Rights:

5. Plea Agreement/Sentence Recommendation:

In return for my guilty pleas to Counts I and III of the Second Amended Information charging Sexual Assault (felony), the State agrees to dismiss Count II at sentencing. The plea is pursuant to Mont. Code Ann. 46-12-211(1)(c). Both parties are free to argue for the appropriate sentence.

I enter a guilty plea to Counts I and III of the Second Amended Information because I am guilty of those offenses. I admit during the 2018 - 2019 school year I was a fifth grade teacher at Orchard Elementary School within Yellowstone County. During that year I knowingly and purposefully touched two of my female students, KD and CR, inappropriately. KD was born in 2008 and CR was born in 2007, so both were under the age of fourteen. The touching consisted of sexual contact with the intimate parts (buttocks and vaginal area) of these two female students over and under their clothing to arouse or gratify the sexual response of either person. These instances occurred in the classroom during school hours.

8. Services of Counsel:

I am satisfied with my attorneys' services and advice and I have had adequate time to prepare a defense. I have received a copy of all of the discovery and investigative reports in this case and have reviewed those with my attorneys.

9. No Other Promises:

I acknowledge receiving a copy of this agreement. No other promises have been made to me.
