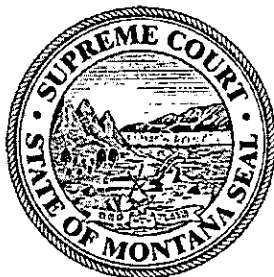

**THE APPELLANT FURTHER CERTIFIES:**

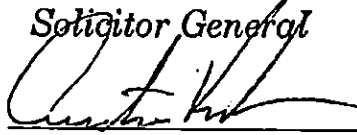
1. That this appeal is not subject to the mediation process required by Mont. R. App. P.

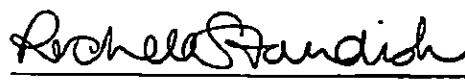
