**COUNT III: AGGRAVATED ANIMAL CRUELTY (FELONY)**  
**(Punishable of up to 2 years in jail and a fine not to exceed 2,500.00)**

The alleged facts constituting the offense are:

That the Defendant, Sean Robert Robinson (born in December of 1986), knowingly or purposely killed or inflicted cruelty to an animal with the purpose of terrifying, torturing, or mutilating the animal; to wit: the Defendant, knowingly or purposely mutilated and decapitated a tabby cat with a gray head and a large white patch covering the cat's snout, cheeks, forehead, and left eye, causing its injury and death in Yellowstone County, Montana; all of which is in violation of §45-8-217(1) Montana Code Annotated (2019) and against the peace and dignity of the State of Montana.

**COUNT IV: AGGRAVATED ANIMAL CRUELTY (FELONY)**  
**(Punishable of up to 2 years in jail and a fine not to exceed 2,500.00)**

The alleged facts constituting the offense are:

That the Defendant, Sean Robert Robinson (born in December of 1986), knowingly or purposely killed or inflicted cruelty to an animal with the purpose of terrifying, torturing, or mutilating the animal; to wit: the Defendant, knowingly or purposely mutilated a Siamese cat with white paws, causing its injury and death in Yellowstone County, Montana; all of which is in violation of §45-8-217(1) Montana Code Annotated (2019) and against the peace and dignity of the State of Montana.

**COUNT V: AGGRAVATED ANIMAL CRUELTY (FELONY)**  
**(Punishable of up to 2 years in jail and a fine not to exceed 2,500.00)**

The alleged facts constituting the offense are:

That the Defendant, Sean Robert Robinson (born in December of 1986), knowingly or purposely killed or inflicted cruelty to an animal with the purpose of terrifying, torturing, or mutilating the animal; to wit: the Defendant, knowingly or purposely drug a black and white cat behind a vehicle with a tow rope, causing its injury and death in Yellowstone County, Montana; all of which is in violation of §45-8-217(1) Montana Code Annotated (2019) and against the peace and dignity of the State of Montana.
