DELIBERATE HOMICIDE (FELONY)

(Punishable by life imprisonment or by imprisonment in the state prison for a term of not less than 10 years or more than 100 years, and punishable by consecutive imprisonment in the state prison for a term not less than 2 years or more than 10 years for use of a weapon)

That the Defendant, BRIJEN JIMOHN FISHER (born January 2003), purposely or knowingly caused the death of another human being, to wit: the Defendant caused the death of T.M. (born January 1998) with a gun, at or near 2701 1st Ave. North in Billings, Yellowstone County, Montana; all of which is in violation of Section 45-5-102(1)(a), Montana Code Annotated, and Section 46-18-221, Montana Code Annotated, for use of a weapon, and against the peace and dignity of the State of Montana.
