The complainant herein personally appears and, being first duly sworn, complains on information and belief against:

charging that in this Precinct, Santa Cruz County, Arizona

COUNT 1
SEXUAL ABUSE

MARCO B SAUCEDO, on or about April 2, 2018, intentionally or knowingly did engage in sexual contact with K.L., a person of fifteen or more years of age, without the consent of K.L., to wit: touched K.L.'s genitals, in violation of A.R.S. §§ 13-1404(A), 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801, a Class 5 Felony.

COUNT 2
SEXUAL ASSAULT

MARCO B SAUCEDO, on or about April 2, 2018, intentionally or knowingly, did engage in sexual intercourse or oral sexual contact with K.L., without the consent of K.L., to wit: digital penetration of K.L.'s vagina, in violation of A.R.S. §§ 13-1406(A), 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801, a Class 2 Felony.

COUNT 3
SEXUAL ABUSE


MARCO B SAUCEDO, on or about December 13, 2022, intentionally or knowingly did engage in sexual contact with M.Y.V., a person of fifteen or more years of age, without the consent of M.Y.V., to wit: touched M.Y.V.'s breasts and nipples, in violation of A.R.S. §§ 13-1404(A), 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801, a Class 5 Felony.

COUNT 4
SEXUAL ABUSE

MARCO B SAUCEDO, on or about December 13, 2022, intentionally or knowingly did engage in sexual contact with M.Y.V., a person of fifteen or more years of age, without the consent of M.Y.V.'s, to wit: touched M.Y.V.'s genitals, in violation of A.R.S. §§ 13-1404(A), 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801, a Class 5 Felony.

COUNT 5
ASSAULT

MARCO B SAUCEDO, on or about December 13, 2022, knowingly did touch M.Y.V., with the intent to injure, insult, or provoke M.Y.V., to wit: touched M.Y.V.'s butt, in violation of A.R.S. §§ 13-1203(A)(3), 13-118; 13-3821; 13-707, 13-802, and 13-812, a Class 3 Misdemeanor.
