under his chin. Caid stated he then left the incident location with his son, believing that he had killed Jasmin. Caid's father (John Stough) stated he received a phone call from Caid after this incident and Caid had told him that he (Caid) had killed Jasmin and had left the incident location with his son. Jasmin's mother (Belinda Rede) stated she had called the kids (Jasmin's children) as she does everyday and the facetime call was answered by Jasmin. Jasmin's mother, said Jasmin was bleeding from her mouth and she stated she was dieing and for her (Belinda) to take care of the kids. Jasmin's mother stated Jasmin then passed out and the phone disconnected. Belinda said she was in a panic and called Caid who did not answer the phone but called back and stated he had killed Jasmin then hung up the phone.

Jasmin was found by paramedics outside of the incident location and transported to Banner University Medical center with seven to eight stab wounds to her torso and neck. Jasmin was transported to the hospital at 15:12 and upon arriving to the hospital underwent emergency surgery and as of 22:36 pm 8/26/2024 was still in surgery.

Justification for Bond Recommendation:

Requesting high bond as Caid is currently on probation when he was involved in this incident with his admission. Caid also made a suicidal statement when he indicated he felt he could not live with what he had done and had harmed himself, requiring medical attention. It is not clear if he will attempt to make contact with the victim during her hospital stay as she will be in a vulnerable state and unable to talk due to being intubated by medical staff.
