15 **COUNT 1: Sexual Conduct With A Minor**

16 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
17 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
18 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
19 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, and 13-801, a class 2 Felony.

21 **COUNT 2: Sexual Conduct With A Minor**

22 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
23 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
24 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
25 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a class 2 Felony.

2 **COUNT 3: Sexual Conduct With A Minor**

3 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
4 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
5 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
6 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a class 2 Felony.

9 **COUNT 4: Sexual Conduct With A Minor**

10 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
11 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
12 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
13 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a class 2 Felony.

15 **COUNT 5: Sexual Conduct With A Minor**

16 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
17 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
18 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
19 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a class 2 Felony.

21 **COUNT 6: Sexual Conduct With A Minor**

22 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
23 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
24 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
25 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a class 2 Felony.

1 **COUNT 7: Sexual Conduct With A Minor**

2 **ZANA HORTON**, on or about 2024 through 2025, intentionally or knowingly
3 engaged in sexual intercourse or oral sexual contact with [REDACTED] who was a minor fifteen years
4 of age or over and the defendant was in a position of trust, in violation of A.R.S. §§ 13-
5 1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a class 2 Felony.

7 **COUNT 8: Luring A Minor For Sexual Exploitation**

8 **ZANA HORTON**, on or about 2024 through 2025, offered or solicited sexual
9 conduct with [REDACTED] knowing or having reason to know that he was a minor, in violation of
10 A.R.S. §§ 13-3551, 13-3554(A), 13-3821, 13-610, 13-701, 13-702, 13-703, and 13-801, a
11 class 3 Felony.
