The State Grand Jury accuses **ROBERT JOSEPH CARRILLO (001)**, charging on this 17<sup>th</sup> day of November, 2025 that in or from Pima County, Arizona:

**COUNT 1**

**BURGLARY IN THE THIRD DEGREE, A CLASS 4 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about September 22, 2025, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on a non-residential structure belonging to City of Tucson, located at [REDACTED] and [REDACTED] [REDACTED] to wit: an electrical box, in violation of A.R.S. §§ 13-1501, 13-1506, 13-701, 13-702, and 13-801.

**COUNT 2**

**TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE,  
A CLASS 2 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about September 22, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of City of Tucson that had been stolen, to wit: Wiring, in violation of A.R.S. §§ 13-2307(B), 13-2301, 13-701, 13-702, and 13-801.

**COUNT 3**

**BURGLARY IN THE THIRD DEGREE,  
A CLASS 4 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about September 30, 2025, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on a non-residential structure belonging to City of Tucson, located at [REDACTED] to wit: an electrical box, in violation of A.R.S. §§ 13-1501, 13-1506, 13-701, 13-702, and 13-801.

**COUNT 4**

**BURGLARY IN THE THIRD DEGREE, A CLASS 4 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about October 2, 2025, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on a non-residential structure belonging to City of Tucson, located at [REDACTED], to wit: an electrical box, in violation of A.R.S. §§ 13-1501, 13-1506, 13-701, 13-702, and 13-801.

**COUNT 5**

**TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE,**

**A CLASS 2 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about October 2, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of City of Tucson that had been stolen, to wit: Wiring, in violation of A.R.S. §§ 13-2307(B), 13-2301, 13-701, 13-702, and 13-801.

**COUNT 6**

**BURGLARY IN THE THIRD DEGREE, A CLASS 4 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about October 10, 2025, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on a non-residential structure belonging to City of Tucson, located at [REDACTED], to wit: an electrical box, in violation of A.R.S. §§ 13-1501, 13-1506, 13-701, 13-702, and 13-801.

**COUNT 7**

**BURGLARY IN THE THIRD DEGREE, A CLASS 4 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about October 10, 2025, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on a non-residential structure belonging to City of Tucson, located at [REDACTED], to wit: an electrical box, in violation of A.R.S. §§ 13-1501, 13-1506, 13-701, 13-702, and 13-801.

**COUNT 8**

**TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE,**

**A CLASS 2 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about October 10, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of City of Tucson that had been stolen, to wit: Wiring, in violation of A.R.S. §§ 13-2307(B), 13-2301, 13-701, 13-702, and 13-801.

**COUNT 9**

**AGGRAVATED CRIMINAL DAMAGE, A CLASS 3 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or between September 22, 2025 and October 10, 2025, intentionally, knowingly, or recklessly, without the express permission of City of Tucson, the owner, did cause damage in the amount of \$10,000 or more, by defacing, damaging, or tampering with Electrical Boxes, located throughout Tucson, buildings, structures, personal property, or places, for the purpose of obtaining nonferrous metals, in violation of A.R.S. §§ 13-1601, 13-1604, 13-701, 13-702, and 13-801.

**COUNT 10**

**TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE,**

**A CLASS 2 FELONY**

**ROBERT JOSEPH CARRILLO (001)**, on or about October 11, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of City of Tucson that had been stolen, to wit: Wiring, in violation of A.R.S. §§ 13-2307(B), 13-2301, 13-701, 13-702, and 13-801.

COUNT 11

THEFT, A CLASS 2 FELONY

**ROBERT JOSEPH CARRILLO (001)**, on or between September 22, 2025 and October 11, 2025, without lawful authority, knowingly did control City of Tucson's ferrous or nonferrous metal to-wit: Wiring, of a value of \$25,000 or more but less than \$100,000, with the intent to deprive City of Tucson of such property, in violation of A.R.S. §§ 13-1801, 13-1802, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the Grand Jurors find that the offenses described above were committed in Pima County, Arizona.
