





Statement of Probable Cause continued:

On January 12, 2026, Officers were dispatched to [REDACTED] reference a shots fired call. The caller was [REDACTED] who reported that her neighbor had shot her husband, [REDACTED].

Officers arrived on scene where they located the victim and all parties involved. [REDACTED] sustained a gunshot wound just below his left peck. It appeared to be a through and through injury that exited towards his back. He was transported to the hospital where his condition was life threatening. Medical staff advised that there was a 50% chance that he would survive his injuries.

Officers detained the shooter Pavan Baron, his wife Dalila Baron. Both made excited utterances that they were defending their son because [REDACTED] assaulted him, then invoked their rights and requested a lawyer. Inside their residence in plain view, officers could see a handgun.

[REDACTED] reported that she and her husband were about to do the laundry. Her family has had several issues with the Baron family. Today, she walked outside to throw the garbage. The dumpster was near the Baron residence. As she was walking back inside her residence, she could hear a scuffle coming from the backyard. As she made her way there, she noticed that [REDACTED] and Pavan were fighting. They were wrestling on the ground while Dalila was striking [REDACTED] in the back with a metal pole. [REDACTED] made her way towards Dalila and shoved her. Dalila then slapped [REDACTED] on the left side of her cheek. Son after, Dalila's son tried to assault [REDACTED] but [REDACTED] was able to shove him out of the way. Dalila walked inside her residence and returned with a back handgun. She handed the firearm to Pavan. By this time, [REDACTED] and [REDACTED] were walking back towards their residence. [REDACTED] had his back towards Pavan, when Pavan shot at [REDACTED] three times. Dalila then retrieved the firearm from Pavan, then pointed the firearm at [REDACTED] face while standing approximately 15 feet away. [REDACTED] was able to walk inside her residence and called 911.

Neighbors were interviewed who verified that they heard three shots.

Detectives served a warrant in Pavan and Dalila residence. There was a black Glock 40 (10mm) handgun. Next to the handgun was a 20 round magazine that was deficient 5 rounds.
