Statement of Probable Cause continued:

On 04/13/2025 at 1038 hours Officers were dispatched to [REDACTED] reference and unconscious male under a Ramada #3. Officer arrived and located the unresponsive male on the ground with extensive trauma to his head area. There was a large amount of blood spatter around and near the victim and there were bloody shoe impressions on the ground. The male appeared to be repeatedly beaten. The victim had a broken jaw, and his teeth were located on the ground. The blood spatter pattern at the scene is consistent with repeated blunt force trauma.

The victim was pronounced deceased on scene, and he was later identified as Michael Lee Baker [REDACTED]. The bloody shoe impressions pattern appeared to have been made by Vans shoes.

The Tucson Fire Department were also dispatched to [REDACTED] and arrived at the same time Officers arrived on scene. The Fire Department left shortly after.

While on today's scene a Tucson Fire Department Captain, who responded earlier to the scene returned. The Tucson Fire Department Captain told investigator that on 04/12/2025 at 2030 hours he and his engine crew responded to the Frys parking lot located at [REDACTED] reference an unconscious male. When they arrived the male regained consciousness and became belligerent towards them and wanted to fight. The male was described as a white male, 19 years old, light brown hair, wearing bloody checkered pattern Vans shoes wearing a light-colored polo shirt, wearing blue jeans and the male had a bloody right hand. The male stated he lived at [REDACTED] he was 19 years old, and his first name was Daniel. Daniel then walked away from the scene and refused medical attention. The Tucson Fire Department then cleared the scene.

Computer research was conducted on the address [REDACTED]. It was learned that Daniel Webster [REDACTED] resides at the address. Daniel matched the description given by the Tucson Fire Department Captain.

Surveillance was conducted at [REDACTED]. At approximately 2020 hours Daniel was identified as being at the address.

A search warrant was served at the address, and Daniel was contacted and interviewed.

The clothing described by the Fire Captain was located in the residence to include a pair of Vans shoes with blood on them.

Daniel stated he remembers being at the park at approximately 1700 hours on 04/12/2025. He was partying with his friends; He drank 12-14 shots of Tequilla or possibly two bottles of Tequilla. He stated he was drunk when he left the park, and he did not remember anything after that. He said he did not remember getting into a fight with anyone. He first stated he remembered going to the Fry's parking lot after the park and breaking his phone then punching a telephone pole. He then said he did not remember anything, and that he was lying.

The pants Danile was wearing today had blood on the right pant leg. The Vans shoes taken from the residence a had a lot of blood on the right shoe and there was less blood on the left shoe. Daniel had an injury to his right knuckle, his nose and his right forehead. Daniel stated his left hip was sore this morning.
