The grand jurors of the County of Pima, in the name of the State of Arizona, and by its authority accuse DUNG T NGUYEN, and charge that in Pima County:

COUNT ONE: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2007 through December 31, 2022, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with S.G., to-wit: BY TOUCHING HER BREASTS, without his or her consent, in violation of A.R.S. § 13-1404A.

COUNT TWO: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2013 through May 21, 2025, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with K.C., to-wit: BY TOUCHING HER BREASTS, without his or her consent, in violation of A.R.S. § 13-1404A.

COUNT THREE: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2018 through December 31, 2018, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with Z.J., to-wit: BY TOUCHING HER BREASTS, without his or her consent, in violation of A.R.S. § 13-1404A.

COUNT FOUR: SEXUAL ASSAULT, A CLASS TWO FELONY

On or about January 1, 2018 through December 31, 2018, DUNG T NGUYEN committed sexual assault by intentionally or knowingly engaging in sexual intercourse or oral sexual contact with Z.J., to-wit: PENETRATED VULVA WITH FINGER(S), without his or her consent, in violation of A.R.S. 13-1406A.

COUNT FIVE: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2021 through May 21, 2025, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with K.J., to-wit: BY TOUCHING HER BREASTS, without his or her consent, in violation of A.R.S. § 13-1404A.

COUNT SIX: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2021 through May 21, 2025, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with A.R., to-wit: BY TOUCHING HER BREASTS, without his or her consent, in violation of A.R.S. § 13-1404A.

COUNT SEVEN: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2022 through May 21, 2025, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with D.M., to-wit: BY TOUCHING HER BREASTS, without his or her consent, in violation of A.R.S. § 13-1404A.

COUNT NINE: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about July 1, 2023 through September 4, 2023, DUNG T NGUYEN committed sexual assault by intentionally or knowingly engaging in sexual intercourse or oral sexual contact with D.B., to-wit: PUT OBJECT IN DB'S ANUS, without his or her consent, in violation of A.R.S. 13-1406A.

COUNT TWELVE: SEXUAL ABUSE, A CLASS FIVE FELONY

On or about January 1, 2025 through May 21, 2025, DUNG T NGUYEN committed sexual abuse by intentionally or knowingly engaging in sexual contact with M.P., to-wit: CUPPING HIS GENITALS, without his or her consent, in violation of A.R.S. § 13-1404A.

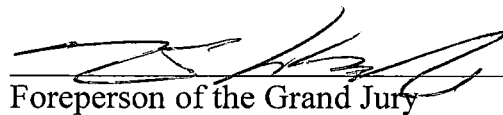
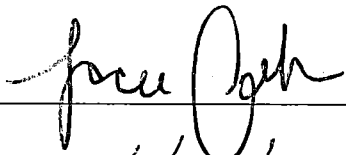
