Statement of Probable Cause:

On 07/19/2026 at 0159 hours multiple shots were fired in front of the address of [REDACTED] after a verbal altercation. Officers with the Tucson police department were in the area, heard the shots and responded. Tucson police officers engaged the suspect shooter (later identified as the defendant) and took him into custody. Other Tucson police officers responded to the incident location where there were several victims with injuries from gunshot wounds and in need of immediate medical attention. Officers with the Tucson Police department render aid to victims. The victims, along with the suspect were transported to the hospital for medical attention. A total of nine victims were shot during the incident all were transported to the hospital for their gunshot wounds.
