Statement of Probable Cause continued:

On 1/24/2025 Amanda Durain called 911 stating her 3-month-old baby, SP, was having trouble breathing and not responding. Amanda's boyfriend, Hunter Poppe got on the phone and said SP's breathing was labored. Hunter was given instructions on CPR. Hunter did CPR until TFD arrived and transported the baby to Tucson Medical Center for treatment. At TMC hospital SP, had a CT scan and was found to have multiple subdurals (brain bleeds) of different ages and sizes. She was transported to Banner University Medical Center for a higher level of care.

At BUMC hospital SP had a full skeletal survey and she was found to have a left tibial corner fracture, age indeterminate fracture of right posterior 11th rib, age indeterminate fractures of left anterolateral 5th, 6th, and 7th rib.

Amanda and Hunter had different accounts of the incident leading up to SP going unresponsive.

Hunter said around 6:30 pm SP woke up restless and they thought she had gas. He did bicycle motions with her legs, laid her on her stomach and rubbed his fingers up and down to shake things around in her belly. Hunter and Amanda took turns trying different things for her stomach. It lasted about thirty minutes. At one point Hunter and Amanda went outside to smoke a cigarette while SP was lying on their adult bed. They heard her crying and went back inside. He started rubbing her stomach and then she started to cry and wouldn't stop. She tensed up and her arms were up by her head. She went pale and stopped breathing. When she took breaths, they were labored and not normal. Amanda called 911 while he started CPR. He continued CPR until TFD arrived and took over.

Amanda said around 5pm SP woke up and they walked with her around their room and played with her. Amanda went to lay SP in the bassinet which is located on the bed and SP fell a few inches into the bassinet as she was laying her down. SP would not go to sleep in the bassinet so Hunter picked her up from the bassinet and placed her on the mattress of the bed. SP fussed a little bit but then fell asleep. They went outside. About 10 minutes later they heard her squeal and went back inside the room. SP was unresponsive, pale and not breathing.

Hunter did not have any explanation for SP's injuries and denied any falls, drops, or shakes.

Amanda did not know how SP received her injuries. Amanda said maybe the exercises they did on her could have caused some of the injuries but SP never cried or looked like she was in pain when they did them. Amanda also suggested that the leg fracture could have been from a diaper change when she kicked her leg out.

SP was evaluated by Dr. Cramton, a (Child At Risk Evaluation Team member) for concerns of non-accidental trauma. In her evaluation she said, "The bony injuries discovered in a 2-month-old who is not rolling, crawling, or walking are consistent with inflicted injury. There are no organic disease processes that cause intracranial bleeding and fractures. Despite the absence of retinal hemorrhages, there is significant concern for abusive need injury."

SP was found to have a nonsurvivable brain injury and died on 1/29/ 2025.

An autopsy of SP was conducted on 2/3/2025. The opinion of Morgan Long, DO was as followed: "In consideration of the known circumstances surrounding this death, the available medical history, and the examination of the remains, the cause of the death is ascribed to blunt force injuries. The manner of death is homicide."
