Statement of Probable Cause continued:

Timothy Ray Munoz was the driver of a vehicle involved in an automobile crash. Security cameras captured the truck being driven by Munoz traveling at an extremely high rate of speed in a residential neighborhood. Munoz lost control of his vehicle, struck and destroyed a utility box on the southern side of the road. The truck then proceeded to completely drive through a center block wall located at [REDACTED]. The vehicle finally came to rest on top of a series of vehicles. The debris from the collision struck numerous other vehicles inside of the yard where the truck crashed through. The amount of damage was well in excess of \$10,000.00.

Inside of Munoz's vehicle was his wife and himself. Munoz's wife sustained mortal wounds and was pronounced deceased on scene.

During contact with Munoz Officers noted he had the following signs and symptoms of impairment:

- Bloodshot/watery eyes
- Slurred speech
- Strong odor of intoxicants emitting from his breath
- Admittance of alcohol consumption
- Difficulty with his short term memory

Horizontal Gaze Nystagmus was administered and noted 6/6 cues of Nystagmus. No other field sobriety tests were administered due to the circumstances.

Munoz was placed under arrest for driving under the influence. A search warrant was obtained and 3 separate blood draws were conducted with an hour in between each draw.
