Statement of Probable Cause continued:

On 06/12/2024 I served the subpoena on Cox who provided the following information;

On 01/14/2025, a warrant was served on the residence of [REDACTED]. Theodore Barr was the sole occupant of the home. Post Miranda, Theodore admitted to searching for and downloading child sexual abuse material and stated that the images can be located on a small black thumbdrive in a cloth like item. Investigators located a small black drive in a blue cloth like coin pouch. After previewing the thumb drive on scene, more than 10 images of children engaged in sexual exhibition of their genitalia or engaged in sexual conduct with adults was located.
