COMES NOW the above-named Defendant in the above-captioned criminal case and under oath states:

1. I am represented by Allen L. Cook III and J. Nicole Jensen, whose address and telephone number are the Ottumwa Public Defender's Office, 109 S. Court, Ottumwa, Iowa 52501, (641) 682-0203.
2. I am currently residing at Southern Iowa Area Juvenile Detention Center and my telephone number is N/A.
3. I was born on 03/29/2005. I can read and understand the English language and have completed the following level of education: 10<sup>th</sup> Grade.
4. I have been advised by the above-named attorneys and understand that I have a right to arraignment in open court, and I hereby voluntarily waive that right, choosing instead to sign this written arraignment and plea of not guilty. I understand that times for further proceedings which are computed from the date of arraignment will be computed from the date of filing this written arraignment and plea of not guilty.
5. I have received a copy of the trial information which charges me with the crimes of Murder in the First Degree, in violation of §§707.1, 707.2(1)(a) of the Iowa Code, a Class "A" Felony; and Conspiracy to Commit a Forcible Felony by Planning or Commission, in violation of §§706.1(b), 706.3(1), a Class "C" Felony. I have read it, and I have familiarized myself with its contents.
6. With regard to the name by which I am charged in the trial information (Initial either "a" or initial and complete "b"):

JG a. The name shown on the trial information is my true name. I have been advised and understand that I am now precluded from objecting to the trial information upon the ground I am improperly named.

\_\_\_\_\_ b. The name shown on the trial information is not my true name. My true name is \_\_\_\_\_. I request that an entry be made in the minutes showing my true name. I have been advised and understand further proceedings will be had against me by that name, the trial information will be amended accordingly, and when the trial information is so amended I will be precluded from objecting upon the ground I am improperly named.

7. I have been advised and understand I may plead guilty, not guilty, or former conviction or acquittal.
8. For the purpose of this arraignment, I have had sufficient time to discuss my case with the above-named attorney, and I waive any further time in which to enter a plea.
9. I plead NOT GUILTY to the charges as filed in the Trial Information.
10. I have been advised and understand that I have a right under Rule 2.33(2)(b) of the Iowa Rules of Criminal Procedure to a trial within ninety days after filing of the Trial Information and initial either "a" or "b":
  - \_\_\_\_\_ a. I demand a speedy trial pursuant to Rule 2.33(2)(b), and request that a trial date be promptly set pursuant to Rule 2.9.
  - 3G b. I waive my right to a speedy trial pursuant to Rule 2.33(2)(b).
11. I also understand that if I am a foreign national I have the right to contact my country's consulate pursuant to Article 36 of the Vienna Convention.
