2-YEAR ADVANTAGE CONTRACT AMENDMENT

This Amendment to your 2018-2019 Housing and Dining Contract (this “Amendment”), is hereby incorporated into and made a part of the Contract. All defined terms not identified herein shall have the meaning ascribed to them in the Contract. Except as modified herein, the Contract remains unchanged and in full force and effect.

Licensors hereby offers you a two-year housing Contract for the 2018-2019 & 2019-2020 academic years at the same room type rates as approved by the Board of Trustees for the current 2018-2019 academic year, upon the terms and conditions hereof, which include a revised cancellation fee schedule. This Amendment provides a two-year housing price rate lock.

1. Section 1 of the Contract is hereby deleted in its entirety and replaced with the following: “**Term**”. This two-year Contract is binding as of the date you or your parent or legal guardian (if applicable) execute this Contract by either signing a printed version or submitting it online. The term of your obligations under this Contract is for two entire academic years (which consists of the fall and spring academic semesters). The University will automatically bill you each semester through Student Account Services. You may only terminate this Contract under the conditions specified in the Contract and most terminations will involve payment to Licensor or the University.”
2. Section 17 of the Contract is hereby amended to include the following additional sentence: “Notwithstanding the foregoing, the housing rate structure from the first year of this Contract will not change for the remainder of this two-year contract.”
3. The entirety of the Cancellation Policy, beginning with the “Summary of Cancellation Policy” on pages 8-11 of the Contract is hereby deleted in its entirety and replaced with the following:

The cancellation of this two-year contract amendment does not cancel the housing contract for 2018-2019. To cancel the 2018-2019 housing contract, all existing cancellation terms apply.

Student is responsible for notifying Campus Housing of cancellation of the Contract. Notification to another University Office will not cancel the Contract.

Beginning May 1, 2018 your signed Contract may only be cancelled without penalty if you are NOT attending the University or BCTC during the 2018-2019 Academic Year.
