

## **Timeline of Events – Fulton Bar (Nuisance Bar Proceedings)**

---

This timeline is being prepared on 27 Sep 11 and all applicable incidents are listed starting with the most recent. Additional events will be added to the end of the list. It should also be noted, that a community meeting was held on 24 Aug 11 at 1900 hours during which time residents, neighbors and citizens were advised of the investigation and provided with questionnaires to complete to document the impact of the nuisance bar on their quality of life. Furthermore, the incidents listed within this timeline only encompass events that occurred at the exact address of the Fulton Bar and don't reflect incidents related to the bar that have occurred in the neighborhood on other streets, however these incidents can be made available upon request.

**17 Sep 11 / 0158 hours      1109-021735      Disorderly Conduct/Noise**

*Police observed a subject exit the Fulton Bar to engage in an argument with another subject in public. This argument was loud and did cause additional patrons of the bar to exit and gather to watch. The subject could be heard yelling more than 50 feet from the bar and was cited with Disorderly Conduct based on his actions.*

**30 Aug 11 / 2342 hours      1108-034829      Fight/Hindering Apprehension**

*Police responded to the bar for a fight in progress. While taking one subject into custody as a result of the fight, other patrons of the Fulton Bar interfered with the Officers making the arrest and were also arrested. Three subjects arrested, all were patrons at the Fulton Bar. During the fight a chair had been thrown through a window and one of the subjects who were arrested had stated, "I'm going to shoot someone".*

**20 Aug 11 / 0137 hours      1108-021416      Fight/Disturbance/Public Drunk**

*Police were dispatched for report of a large fight at the bar. Based on the number of people involved, multiple officers from Patrol, SOG and CID responded. Arrests made and at least two subjects had been injured, one from being thrown through a plate glass window. Large crowd would not initially disperse.*

**13 Aug 11 / 2046 hours      1108-014409      Noise Ordinance (Gang Issue)**

*Police received at least two calls regarding the "Wheels of Soul" (OMG), Pagans (OMG) and Strong Arm (affiliated with the Pagans) arriving at the*

***bar riding on approximately 30-40 motorcycles and were revving the engines excessively.***

***13 Aug 11 / 1846 hours 1108-014302 Noise Ordinance/Suspicious Activity***

***Police dispatched to the bar in response to the "Wheels of Soul" (OMG) arriving at the bar on multiple motorcycles that were extremely loud.***

***03 Aug 11 / 0132 hours 1108-002319 Public Drunk / Disturbance***

***Police dispatched to the bar for a disturbance. A patron of the bar was arrested for Public Drunk and Disorderly Conduct. Citations issued. The patron had been in the street yelling, causing a disturbance after having been involved in a physical altercation.***

***03 Aug 11 / 0043 hours 1108-002288 Person Stop/Trespass by Motor Vehicle***

***Police observed a subject outside the bar in a parking lot sitting in a motor vehicle. Subject approached by Police and found to be trespassing. It appeared to the Police that this subject may have been waiting for another subject and appeared to be suspicious in nature. Subject was advised and left area.***

***01 Aug 11 / 0108 hours 1108-000032 Aggravated Assault/Firearms Violations***

***Police were dispatched to the Fulton Bar for report of a patron outside the bar with a firearm and that he had fired the gun at an occupied vehicle leaving the scene. Lancaster Coalition captured the entire incident on film. The subject with the gun was observed in the bar, witnesses placed him in the bar and describe him engaging in an argument with other patrons before taking the firearm out and shooting at the vehicle. The "bouncer" was observed not taking any action or calling the Police and it was apparent that the Suspect was not checked for weapons prior to entering the bar. Police were directed to the suspects location by the Coalition operators and during the incident, the Suspect was shot by Police while still in possession of the firearm. Suspect was arrested and Police recovered the firearm. This incident required numerous Detectives to respond for the investigation that included two separate crime scenes and several witnesses that needed to be interviewed.***

**24 Jul 11 / 0213 hours 1107-026361 Disturbance/Noise**

***Police were dispatched for a disturbance in progress and upon arrival observed loud patrons leaving the Fulton Bar. The arrival of the Police facilitated these patrons leaving the area and lowering the noise levels.***

**20 Jul 11/0127 hours 1107-021626 Disturbance/Noise**

***Police were dispatched for a disturbance involving patrons of the Fulton Bar as they exited the premises. Group was moving upon Police arrival. Caller is a resident in the neighborhood.***

**09 Jul 11 / 0022 hours 1107-009294 Littering**

***Subject observed by Police throwing a cigarette box onto the ground outside the location and who also refused to pick the trash up. Subject found to be an employee of the bar. Cited.***

**08 Jul 11 / 0156 hours 1107-008233 Disturbance/Noise**

***Police dispatched for a disturbance in progress. Upon arrival made contact with two patrons of the Fulton Bar engaged in a loud verbal argument outside the premises. Same two subjects had been involved in similar conduct three hours prior that Police were involved in and both were still patronizing the bar. (See next incident)***

**07 Jul 11 / 2237 hours 1107-008121 Disturbance/Noise**

***Police observed an argument between two patrons of the Fulton Bar in public. Both subjects were loud and argumentative. Both were advised to leave the area.***

**29 Jun 11 / 0053 hours 1106-032784 Disturbance/False ID to Law Enforcement**

***Police were dispatched to Fulton Bar for report of a fight/disturbance. Upon Police arriving in the area at least one subject was observed attempting to run from the scene. Both subjects were found to be minors (under the age of 21). One of them provided fictitious information about his identity which included his date of birth. Both arrested, charged and/or cited.***

**22 Jun 11/1157 hours 1106-025126 Found Weapon (Firearm-previous incident)**

***Resident in neighborhood found a loaded .45 caliber handgun (7 rounds ammunition) that appeared to have been discarded. Firearm surrendered to Police and believed to be same firearm related to prior incident (See next incident)***

***22 Jun 11/0034 hours 1106-024694 Drugs/Warrant/Firearm Incident***

***Police located a wanted subject inside the bar and when attempting to take him into custody he fled on foot. During the pursuit, Police observed Suspect discard firearm but could not locate it. Suspect in possession of a digital scale and quantity of Marijuana. Subject also had a bench warrant. Determined to have been inside bar with drugs and a weapon prior to fleeing from Police.***

***16 May 11/1957 hours 1105-017826 Weapons/Public Drunk***

***Police dispatched for a weapons call. Upon arrival located a subject involved in a disturbance that had been a patron of the Fulton Bar and was found to be visibly intoxicated and a danger to himself/others as well as a nuisance to other. Arrested.***

***11 May 11/0135 hours 1105-010980 Fight In-Progress***

***Police dispatched for a fight in progress at the Fulton Bar involving numerous patrons. Upon arrival, Police observed large groups of patrons leaving the area. Groups were loud while leaving the area.***

***10 May 11/2122 hours 1105-010834 Fight In-Progress***

***Police dispatched for a fight in progress at the Fulton Bar involving patrons. Upon arrival of several Police Officers, no fight was located.***

***22 Apr 11/2204 hours 1104-023747 Harassment/Domestic***

***Police dispatched for a domestic dispute that had just occurred. Upon arrival made contact with both parties at the Fulton Bar. One subject involved also found to be visibly intoxicated. Arrested for harassment and public intoxication.***

***20 Apr 11/0036 hours 1104-020677 Disturbance***

***Police dispatched for a disturbance at the Fulton Bar. Upon arrival Police checked the area and maintained a Police presence to prevent further incidents.***

***14 Apr 11/0225 hours 1104-013980 Noise Ordinance***

***Police dispatched for report of loud noise from patrons leaving the bar. Police arrived in area and observed patrons leaving. Reporting person was a resident that lives in neighborhood.***

***12 Apr 11/2319 hours 1104-012847 Noise Ordinance***

***Police dispatched for report of loud music from bar. Reporting person is resident in neighborhood who complained. Upon Police arrival, noise was reasonable however, Police were not present at the time of the complaint by the neighbor/resident.***

***02 Apr 11/1617 hours 1104-001725 Traffic Complaint/Gang Activity***

***Police dispatched for a traffic complaint involving 30-40 motorcycles. Upon arrival Police observed numerous members of the Pagans (Outlaw Motorcycle Gang) in the area, motorcycles were loud and gang members were wearing insignia to represent their membership with the gang. Several Police Officers detailed to area to monitor activity.***

***30 Mar 11/0034 hours 1103-030964 Noise Ordinance***

***Police dispatched for report of loud music/noise from bar. Reporting person is a resident in neighborhood who complained. Upon Police arrival, noise was reasonable however, Police were not present at the time of the complaint by the neighbor/resident.***

***29 Mar 11/1847 hours 1103-030693 Fight***

***Police dispatched for report of a fight in progress. Upon arrival, groups moving from area but not active fight observed. Police remained in area to ensure groups continued to keep moving away from area.***

***26 Mar 11/2337 hours 1103-027871 Assault (Harassment)***

***Police dispatched to bar for report of an assault that had just occurred inside the establishment. During investigation Police learned that a cell phone had been stolen inside the bar from a patron who then assaulted the person believed to have taken the phone who retaliated.***

***19 Mar 11/0014 hours 1103-019424 Noise Ordinance***

***Police dispatched for report of loud music from bar. Reporting person is a resident in neighborhood who complained. Police made contact with bar employees and advised them of the complaint with respect to being considerate of residents in neighborhood.***

***27 Feb 11/0214 hours 1102-027867 Aggravated Assault***

***Police dispatched for report of an assault that had just occurred. During investigation, Police determined that one patron struck another patron in the neck with an unknown object. One subject charged with Aggravated Assault.***

***13 Feb 11/1836 hours 1102-013509 Robbery***

***Police dispatched for report of a robbery. Upon arrival, Police made contact with Victim, a patron at bar who stated another subject had attempted to rob him at this location at which time the Victim resisted and the assailant fled.***

***12 Feb 11/0012 hours 1102-011830 Noise Ordinance***

***Police dispatched for report of loud music/noise complaint at bar. Police sat in area for 10 minutes observing loud patrons going to and from the bar. Subjects advised by Police to keep noise levels down.***

***29 Jan 11/2208 hours 1101-29405 Fight***

***Police dispatched for report of a fight in progress. Upon Police arrival, no fight was observed. Several officers responded. Police remained in area for several minutes to monitor activity.***

***10 Jan 11/2321 hours 1101-009940 Assault/Public Intoxication***

***Police dispatched for report of a fight inside the bar. Upon arrival Police learned a fight had occurred inside the bar. One of the combatants was found inside the bar to be visibly intoxicated to the degree that he was a danger to himself and others and was subsequently arrested. Other parties involved in the fight had fled prior to Police arrival.***

***13 Nov 11/2248 hours 1011-013579 Noise Ordinance***

***Police dispatched for report loud music. Upon arrival Police observed that a live band had been performing at the Fulton Bar and had just finished. Police did not witness a noise violation but were not present at the time the neighbor/resident made the complaint.***

***28 Oct 10/2052 hours 1010-030131 Disorderly Conduct/False Identification***

***Police dispatched for a disturbance at the Fulton Bar. Contact made with one subject who was arrested and then provided false information as to his identity. While incarcerated subject attempted to break video equipment at the Police station. Subject found to be only 19 years of age. Subject found to be extremely intoxicated.***

***22 Oct 10/2346 hours 1010-023609 Fight***

***Police dispatched for a fight at the Fulton Bar. Upon arrival Police made contact with an individual who was attempting to engage in a fight with another subject. Identified and directed to leave area.***

***29 Aug 10/2217 hours 1008-032667 Noise Ordinance***

***Police dispatched for report of loud music at the Fulton Bar. Upon arrival, Police observed a live band performing and that the music level was loud. Police advised employees of bar to turn volume levels down with regards to a noise ordinance violation. Police were told that the band was done playing for the night anyway.***

***28 Aug 10/2348 hours 1008-031652 Disturbance/Public Intoxication***

***Police dispatched for report of a disturbance in front of the Fulton Bar. Police made contact with a highly intoxicated subject at the bar who was causing a disturbance and who was subsequently arrested for Public Intoxication.***
