PROXY STATEMENT

A Special Meeting of the Shareholders is to be held at 2 p.m. Thursday, Feb. 22, 2024.

Meeting Information. The Board of Directors of Louisiana Press Association, Inc. (the "Association") is soliciting your proxy to be voted at the Annual Meeting of Shareholders to be held at 2 p.m. on Feb. 22, 2024, at the LPA's building, 4000 S. Sherwood Forest Blvd. Suite 502, Baton Rouge. The meeting also can be attended via webinar.

Purpose of Meeting. The purpose of the Meeting is to vote to amend the bylaws of the corporation.

The Board of Directors urges you to complete, sign and return the Proxy Card included with this Proxy Statement, whether or not you intend to be present at the Meeting. It is important you return the signed Proxy Card by Feb. 15, 2024, to help assure a quorum for the meeting.

General Voting Information. The person designated on the Proxy Card will be authorized to vote at his/her discretion on any matters that may come before the meeting. If you sign and return the proxy form, you may still attend the meeting to vote your share in person. You may also revoke your proxy at any time before the meeting: (i) by notifying the Association in writing at 4000 S. Sherwood Forrest Blvd. Suite 502, Baton Rouge, Louisiana 70816; (ii) by submitting a later signed Proxy Card; or (iii) by voting your shares in person at the Meeting.

This proxy solicitation is being made largely by email, but may also be made by officers or employees of the Association, through mail, telephone, facsimile, oral, or other communications. Proposal 1: To Amend the Corporation Bylaws

With creation of the 501 (c)6 entity per the shareholders previous approval, the corporation bylaws are being fully amended. The amended emails are on the following pages.

Required Vote: A two-thirds (2/3) vote of the voting shares present is required to amend the Bylaws.

Proposal 2: Donation of shares to 501(c)6

The shareholders previously approved the formation of a 501(c)6 for membership services. The majority of stockholders of the corporation have donated their shares to the 501 (c)6. The Remaining Shareholders of the Company shall contribute all of their outstanding shares of the Company to the newly formed Tax-Exempt Trade Association, contingent on all members of the Company consenting to such contribution either voting in person, by proxy, or separate act of donation.

Required Vote: This must be unanimous consent.
