NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE SUSAN ROSS: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of AMADOR COUNTY, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of BOARD OF TRUSTEES MEMBER FOR DISTRICT 4 OF THE AMADOR COUNTY UNIFIED SCHOOL DISTRICT BOARD OF TRUSTEES, in AMADOR COUNTY, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

- Failure to provide competent budget oversight.
- Allowed district administration to withhold information from the public.
- Failure to provide fair hearings and due process for employees.
- Exhibited unacceptably poor judgment by voting to fire Principal Laurie Carson (Amick).
- Violated state law by modifying school board bylaws to be inconsistent with the Education Code.
- Violated the state's open meeting law by attempting to force the public to leave a meeting without due cause, failing to announce closed session actions, and polling board members before decisions are made.

Ross has shown great disrespect to the public, employees, and board members. She:

- Discourages board members from having open, transparent discussions with constituents.
- Limits board member comments and responses to public comments.
- Puts her personal loyalty to the superintendent ahead of the public and students' interest.
- Supports a culture of fear and retaliation.
- Does not listen to members of the public, employees or constituents.

The public deserves a trustee who will put our students', educators', parents', and taxpayers' interests first.
