Ricky has also been known to have trunk or treats at his Church, which has been free to anyone in the community, not just his Church members. He provided free food, candy, and bounce houses for kids. I have also seen Ricky pour into many adults in the community as well. He has helped people with resumes for jobs, and/ or get their business license to start their business. I have only seen positive things from Ricky in the community. I can honestly say this is out of character for the Ricky that I know. I humbly ask for leniency for Mr. Taylor and that you consider all the good things Ricky has done and continues to do for the youth in the community.


