**Late Fees:**

- A \$100 late fee will be charged for any legal notice submitted within the first 24 hours after the deadline.
- A \$200 late fee will be charged for any legal notice submitted 24 hours after the deadline.

**Cancellation/Set up Fees for Foreclosures:**

**If a cancellation notice is provided before the initial publishing deadline date.**

- A \$75 set up fee will be charged for legal notices priced up to \$300.
- A \$100 set up fee will be charged for legal notices priced \$301 - \$499.
- A \$125 set up fee will be charged for legal notices priced \$500 and up.

**If a cancellation notice is provided after the initial publishing date.**

- A 25% surcharge will be applied to all legal notices that have been published a minimum of 1 time.
- A 20% surcharge will be applied to all legal notices that have been published 2 times.
- A 15% surcharge will be applied to all legal notices that have been published 3 or more times.

**▶▶ Notices NOT submitted to one of the emails above will not be confirmed and may not be published.**

All foreclosure sales in Georgia are held at the county courthouse on the first Tuesday of every month unless the first Tuesday is a holiday. The sale must be conducted between 10:00 a.m. and 4:00 P.M.

In the event the first Tuesday of the month is a holiday, the foreclosure sale will be held on the first day the courthouse opens for business after the Tuesday holiday.
