IS GIVEN:

A Petition has been filed with the Court. The Petition have been brought pursuant to Minn. Stat. §501C.0101, et. seq., including but not limited to Minn. Stat. § 501C.0202(3), (4), (6), (9), (10), and/or (13) The Petition requests the Court issue an Order:

(1) Determining that the August 2019 restatement of the Sam Daml Revocable Family Trust Dated October 10, 2011 (the "Trust") is legally invalid and unenforceable because Judy Ann Daml lacked capacity to understand and/or execute the same, and/or because Shelby Medders unduly influenced Judy Ann Daml;

(2) Determining that the Trust, as restated on March 8, 2017, is the legally valid and enforceable trust agreement;

(3) Appointing Presbyterian Family Foundation as Successor Trustee of the Trust (and removing any (purported) Successor Co-Trustees as designated by any restatement of the Trust, if necessary to be determined);

(4) Directing that the administration of the Trust be done under Court supervision;

(5) Allowing Petitioner's attorney's fees and legal costs to be paid by the Trust; and

(6) For any other relief allowed as determined to be just and equitable.

Notice shall be given to all persons named in the Petition as having or as claiming an interest in the referenced Trust. Notice shall be given by mailing a copy of this Notice of Hearing and Order to all persons named in the Petition as having or who may have claim to have an interest in the referenced Trust, at their last known addresses by U.S. Post Service at least 15 days prior to the hearing date; and publishing this Notice of Hearing and Order one time at least 20 days prior to the hearing date in a legal newspaper of Mille Lacs County, Minnesota.
