## **PUBLIC NOTICE INFORMATION**

Miami-Dade County intends to apply for a grant of up to \$4,080,590.00 in CDBG-CV funds through the Florida Department of Economic Opportunity competitive process. This program is designed to provide entitlement communities such as Miami-Dade County funds to prepare for, prevent, or respond to the health and economic impacts of COVID-19. The activities must be primarily for the benefit of low- and moderate-income residents. Under the CARES Act, funding is available through the Community Development Block Grant Program for activities that prevent, prepare for, and respond to the coronavirus pandemic.

Public Housing and Community Development (PHCD) will hold a public hearing on Monday, October 25, 2021, beginning at 10:00 a.m. The public is invited to attend either in person at the Stephen P.
