**ONLY ONLINE APPLICATION WILL BE ACCEPTED**

Notice is hereby given that the HHA will open its PH waiting list in accordance with regulations outlined by the Department of Housing and Urban Development (“HUD”) and its Affirmative Fair Housing Marketing Plan. Applicants must meet all HUD income and eligibility requirements in order to qualify for the program. The following information is needed in order to successfully submit the application: Names, social security numbers, birthdates and income information for everyone in the household.

**Applications will be available on the HHA website at <https://hialeahhousing.housingmanager.com/> from September 30, 2019 at 12:01 a.m., to October 4, 2019 at 11:59 p.m.**

**Submission of application does not guarantee placement on the waiting list.** Due to the high level of interest in the PH program, HHA will use a random lottery system to select a total of 280 families from all applications submitted and those selected applications will be placed on the waiting list. The time and date of receipt of the application during the wait list opening has no bearing on whether an application will be selected. Families will be listed on the waiting list in the order determined by their selection in the random lottery.
