NOTICE OF PUBLIC HEARING ON PROPOSED FY 2021 ACTION PLAN WITH FUNDING RECOMMENDATIONS FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME), HOUSING DEVELOPMENT ASSISTANCE GRANT (HODAG) PROGRAM INCOME, AND EMERGENCY SOLUTIONS GRANT (ESG) PROGRAM FUNDS; AND SUBSTANTIAL AMENDMENTS TO FY2013-2020 ACTION PLANS AND FY 2013-2017, AS EXTENDED THROUGH 2019, CONSOLIDATED PLAN AND FY 2020-2024 CONSOLIDATED PLAN FOR THE RECAPTURE AND REALLOCATION OF CDBG, AND CDBG CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY (CARES) ACT (CDBG-CV), AND FOR THE ALLOCATION OF HOME AMERICAN RESCUE PLAN (ARP) FUNDS

The Miami-Dade Public Housing and Community Services Committee will hold a public hearing for actions described below on Thursday, July 15, 2021 at 9:00 a.m., or at the Board of County Commissioners (BCC) meeting scheduled for Tuesday, July 20, 2021 at 9:30 a.m. if not approved at committee due to cancellation of the meeting or lack of quorum. Subsequently, the actions described below will be considered for final action by the BCC on Tuesday, July 20, 2021 at 9:30 a.m. Both meetings will be held inside Board of County Commission Chambers located on the second level of the Stephen P. Clark Center, 111 NW 1st Street, Miami, Florida 33128. The purpose of the hearing is to give the public an opportunity to comment on the proposed FY 2021 Action Plan Funding Recommendations for CDBG, HOME, and ESG Program Funds and Substantial Amendments to the FY 2013-2020 Action Plans and the corresponding FY 2013-2017, as extended through FY 2019, Consolidated Plan and FY 2020-2024 Consolidated Plan, for the recapture and reallocation of CDBG, HOME funds, and HOME American Rescue Plan Program Funding Recommendations.

The public shall have an opportunity to comment on the following proposed actions;

- Approval of the FY 2021 Action Plan and update to the FY 2020-2024 Consolidated Plan in order to allocate \$13,296,032.00 of CDBG Program, \$4,879,890 of HOME Program, \$3,514,740.00 of HoDAG Program Income and \$1,126,512.00 of ESG Program funds.
- Approval of Substantial Amendment to the FY 2013-2020 Action Plans and corresponding FY 2013-2017, as extended through 2019, Consolidated Plan and FY 2020-2024 Consolidated Plan in order to recapture up to \$600,000.00 of CDBG and up to \$584,033.00 of CDBG Coronavirus Aid, Relief and Economic Security (CARES) Act (CDBG-CV) funds.
- Approval of Substantial Amendment to the FY 2020 Action Plan and corresponding FY 2020-2024 Consolidated Plan in order to allocate \$17,686,235.00 of HOME American Rescue Plan (ARP) funds.
- Authorize the County Mayor or the County's Mayor designee to submit to the United States Department of Housing and Urban Development (HUD) the FY 2021 Action Plan and Substantial Amendments to FY 2013-2020 Action Plans and the corresponding FY 2013-2017, as extended through 2019, Consolidated Plan and FY 2020-2024 Consolidated Plan.
