# Rebels heading to state

It was an exciting week for the Moose Lake Willow River Rebels boys' basketball team. They defeated Duluth Marshall and Pequot Lakes to earn a spot in the Minnesota State Basketball Tournament. There are eight teams left: In the northern section-Minneapolis North (14-1) is seeded number one, Annandale (18-1) second, Fergus Falls (15-7) third and Moose Lake Willow River (18-3) fourth. In the southern section-Waseca (20-1) is number one, Caledonia (21-1) is second, St. Croix Prep Academy (20-1) is third, and Morris Area Chokio-Alberta (19-2). MLWR played Minneapolis North on Wednesday, March 31 at 1:00 in Osseo (after this paper's deadline). The only other time MLWR has won the sections to go to state was in 2005. The winner of the game Wednesday will play the winner of Caledonia and St. Croix Prep Academy on April 7 at the Target Center at 2 p.m.

Two of Rebels losses this season were to Duluth Marshall 69-70 and Pequot Lakes 84-87 in overtime. These are the two teams that they had to defeat

this week to go to state and

On Tuesday, March 23 the Rebels were at Duluth Marshall again and shot the lights out. Mason Olson put in 32 points and Logan Orvedahl added 16. At the half, the Rebels led 44-28. The Marshall Hilltoppers were down by 17, but then went on a 12-0 run to close the gap to 53-48 with 12 minutes left in the game.

The Rebels have been shooting almost 50 percent from the three-point mark. Rebels' Coach Wes Cummins said, "It's such a momentum changer when you hit one. It's a nice luxury to have." Orvedahl had four in this game, Phillip Sheetz three, Olson and Carter Johnson each had two. They made 12 of their 13 free throw shots, while Marshall was 2 for 4 from the charity stripe.

Hilltopper's coach, Tom Mitchell stated that the Rebels shot the lights out and played incredibly hard for all 36 minutes. It was hard to match.

Scoring for the Rebels were Olson 32, Orvedahl 16, Johnson, Sheetz 9, Brady Watrin 7, Landin Kurhajetz 6, and Sam

For Marshall, the Timm brothers were the leaders.

# County Board approves two township projects for grant cycle

The Carlton County Board of Commissioners gave their blessing for two township grant projects that will compete for limited transportation funding from an annual Legislature initiative for Greater Minnesota. County Engineer Neumann requested the Board's support at the Adjourned Session of the County Board on February 22.

Almost all the Carlton County townships inquired into the possibility of funding needed township road projects, but the Highway Department staff explained that the competition throughout the State was strong and success was not good. A proposal must show that the particular project was important to the traffic and trade needs of the local area and have an impact to the region served.

The Townships of Moose Lake and Barnum have requested funding for the Aspen Road, bordering each township line, for a rebuild of 2 ½ miles and an application of pavement. Aspen Road runs North and South connecting CSAH 6 and Old Highway 61. The pavement and road base have been poor for years.

poor for years.
Eagle Township is requesting funding an upgrade of the Kingsley Road. Rebuilding the roadbed and paving are called for in the plan. This road provides partial access to the north side of Eagle Lake and would also provide a detour route for Hwy 73 traffic when work is being done on that thoroughfare.

The next meeting is March 15. With the planning and construction of a new jail taking at least the next three years, this standing committee will meet regularly to follow the progress, ask questions, and spread information into the community.

Locations and options for receiving COVID-19 vaccines continue to open up across the state of Minnesota

Current Center for Disease Control (CDC) and Minnesota Department of Health (MDH) guidelines allow for all Minnesotans age 16 and older to sign up for an appointment to receive their vaccines. This change by the Minnesota Department of Health and the Governor's Office began on Tuesday, March 30. Groups considered high risk, the elderly and frontline workers are still considered priority groups. Vaccination centers continue to follow MDH and CDC guidelines on who receives vaccine priority.

# Saving labor pensions, a little known story

1400 and a 1.9 trillion Covid-19 response bill is big news at this time. With some glitches, electronic transfers and checks are on the way. Yet another big story included in the response bill centers around \$86 billion set aside to stabilize distressed multi-employer pension funds for the next three decades.

Employee pension funds are built on employee contributions over a period of time, some stretching into decades. Those working pay in to cover their pension at retirement but in fact help pay for fellow employees that have retired. A fund remains solvent if there is a strong workforce paying in, making steady contributions.

There are 1.5 million active and retired union workers affected nationwide, including about 23,000 Minnesota retirees who paid into the Central States Pension Fund. Trouble in funding these retirement benefits did not come over

In the financial collapse of 2008, too much of the reserve pension fund money had been invested in high yield Wall Street schemes that lost value quickly. Healthy reserve fund balances disappeared even though those workers contributing continued to apply their share into the same pension plans. At the same time there continued a

loss of union jobs nationally which also put pressure on the pension

Many of the pension plans started paying out more to retirees than workers were sending in. The trustees or supervising staff of these pensions warned that without Federal action the money would run out in 2025. Former Minnesota Congressman John Kline was successful in legislation that did not give more Federal aid but did give the trustees the right to cut retiree benefits

Some retirees faced pension cuts in the range of 47%. Senator Tina Smith met with labor leaders specializing in the pension issues in 2018, realizing how many workers were affected by this issue. She remembered hearing from one woman in Duluth who said, "I saved and I did everything right . losing my pension looks like I will be living under a bridge."

US House of Representatives input on this issue for inclusion in the stimulus package came from Reps. Bobby Scott (D-VA) and Ritchie Neal (D-MA) and Senator Tina Smith kept up the pressure in Senate deliberations. They were successful when the whole act was signed by the President. Local Cloquet labor activist and

long time member of the Teamsters Union Sherman Liimatainen co-chaired the American Pension Justice group that lobbied for

several years for Federal action. Liimatainen commented, "Of course investing in the pension funds is economic stimulus. Renewed pension funding will stimulate years of robust spending for our local and national economies.

Not all unions have had mem-bers working during this Covid-19 period. The Musicians Union, for example, has seen Broadway theaters shut down, regional theater and concerts cease, and musicians struggling in local venues. Barbra Eliason Dunkel, native of Kettle River and an attorney in New York now living in Minneapolis, was married to a symphony conductor and who was a member of the Musicians Union.

Eliason Dunkel observed "Members of the union that have pensions have been told their income will face cuts from that source, some losing half of their monthly check. This pandemic has crippled the music industry and has dried up pension funding." When will the first money go

out to pension funds? Liimatainen cautioned patience. Even though the funding is available, this new Federal money will take a period of time for rule making and major discussions on how the program will be implemented. It is estimated that some affected pension plans would not be allowed to submit applications for financial assistance until March 11, 2023.

Jeff Telker was born August 13, 1952 in Moose Lake to Rudolf "Rudy" and Hulda (Johnson) Telker. He departed to be with his Lord on Friday, March



26, 2021 after a courageous battle with ALS. He is survived by his wife, Mary Beth; children, Anne (Andy) Flagge, David (Mary), Russell; grandson, Oscar Flagge; his mother, Hulda; sisters, Susan Kotowski and Karla (Randy) Tschetter; God-daughter, Janna Bode and the entire Bode family, including Shawn, Kelly, Ally, Aaron and Reese.

He was preceded in death by his father, Rudy; and brothers-in-law, Ed Kotowski and Lorin Emrick.

Jeff lived a life of service. He was a lifelong member and deacon of Mahtowa Covenant Church. His community service included the Barnum Fire Department, Barnum School Board, Covenant Park Bible Camp board of directors, and Habitat for Humanity. He went on several Alaskan service trips and worked tirelessly at the Bible camp. He often commented that his greatest gifts were his wife Mary, his family, his Christian faith, and the work ethic instilled by his parents.

He was deeply committed to his family, and holidays often meant driving to connect with his extended family in the Twin Cities, Sioux Falls, or Iowa.

Jeff was a kind and helpful man. Without reservation, Jeff accepted requests for assistance with any building project, although he wasn't as excited about plumbing as carpentry. He said each new project was an excuse to buy another tool that Mary might or might not find out about. He was rarely happier than when he was swinging a hammer or cutting lumber. He was a talented carpenter but made an occasional measurement mistake resulting in a board that was usually an inch too short. In those instances, he'd shake his head and point out that short board would certainly be needed elsewhere before the project was over. He was usually right.

Although infinitely patient with people, Jeff couldn't sit still. He liked to be busy; his garage,

house, and helper projects often running together. He deer hunted but the time in his deer stand was measured in minutes, not hours, and was often filled with thoughts of what he needed or wanted to do next. The other noteworthy exception to his patience was a cat who was trying to help him with a flooring project. It's rumored that the cat survived, but there was a piece of sheetrock with a hammer shaped dent he later repaired.

Jeff's two guilty pleasures were coffee (with real cream, not adulterated with flavored creamer) and talking. Jeff had a quick wit and was known to hold up both sides of a conversation if the talk slowed. He met regularly with the Mahtowa Covenant Church men's group, the Classic Car Rally (a discussion group in Tom Class' garage), and with friends and relatives. If there was coffee and talk, Jeff would be there. When together with cousins Jerry Telker, Sonny Carlson, and Dean Hovey, Jeff sometimes struggled to get a word in. (It was tough, but Jeff managed).

ALS slowed him down, but he continued to "have coffee" with church friends, a Bible study, and his network of buddies. Jeff read more and was amused that he, cousin Sonny Carlson, and friend Tom Class were included as fictional characters in a mystery books set in Pine County. Jeff evolved into a proof-reader for cousin Dean Hovey, and they spent hours discussing the characters, plots, the parts that made him laugh, and the corrections.

Somewhere in heaven there's a table set with steaming cups of coffee. Jeff's there talking carpentry and cars with the other saints.

# April showers bring more than just flowers

It's raining now. A slow, soaking rain. The kind we like in the early days of spring because it helps reduce the fire danger before everything 'greens' up. It has also been a day

of phenological significance. Phenology is the observation and recording of seasonal events in nature and springtime is one of the very best times of year to make those kinds of observations, since so many new things are appearing nearly every day.

There must have been a south wind that blew the birds into our yard this morning. Big flocks of dark eyed juncos were scattered in the trees and on the ground, hopping around in search of bits of food. Then we saw four Redwinged Blackbirds. Joining them on the birdfeeder were two male

Purple Finches. A moment later a Brown Creeper appeared on the trunk of the red pine, hopping upward towards the suet feeder. All of these were exciting sights. but the best was the discovery of two Gold-crowned Kinglets flitting around the branches of the silver maple. The bright yellow stripes on the top of their heads glowed in the grayness around them. These birds are normally found further in the forest, and even then they are hard to spot. Later on a group of Fox Sparrows were seen doing their quirky hop and skip dance under the spruce tree as they tried to uncover seeds or larvae.

It was a day when these birds, most of whom have already traveled long distances, were refueling for the rest of their journey. Some, like the kinglets and juncos, will go as far as the northern limits of Canada to find mates and nest. And at this time of year in northern Minnesota, the rain can easily turn to snow, effectively hiding the food they need for survival. These little feathered bits of life are harbingers of even more beautiful

and bounteous birds to come in the weeks ahead. On a day like this, we need that kind of promise.

April is a month that promises big changes in the surrounding woods and fields. Before the month is over we will be looking for the crocuses to burst into bloom, giving us a jolt of color for our winter weary eyes. Two more subtle and delicate flowers are ones that I will have to look more closely for because both flowers are ephemeral, only blooming for a short time before the trees leaf out and other vegetation outgrows and

overshadows them.
The first is Trailing Arbutus, the more difficult of the two to find, but worth the search. We are lucky because it grows in our sandy, acid soil. Trailing arbutus belongs to the Heath family and is technically considered a shrub. Creeping along the ground with woody stems and leathery leaves that stay green throughout the winter, it depends on mycorrhiza (a type of fungus) in the soil to get

# April showers may be hard to come by this year

We TV weathercasters just love our cliches. I remember one eager young person who joined our team fresh out of meteorology school in 1993 being all excited to tell people to remember their umbrellas during his first rainy day on duty. I asked him how many people up here actually use umbrellas. Then he came up with the idea to compare rainy days with ducks. Call me a mean old party pooper but I told him that was

old hat, too.
Another old cliche we beat into the ground deals with our region's up and down temperatures. We always compare that to a roller

coaster. Well, it has been quite a roller coaster around here in 2021. January was nearly eight degrees warmer than normal. February was nearly eight degrees cooler than normal. March went back up to eight degrees warmer than normal.

For April, the long range forecasters think temperatures will average two degrees warmer than normal. For April's precip prediction, despite an uptick in rain in March, we could still use more to fight off the abnormally dry conditions our region has faced for many months. However, we may not get much relief from that this month. Those same long range forecasters think the Upper Midwest will come up a half inch short for rainfall in

the month of April. April's warmer than average prediction will probably come courtesy of one big warm spell because most of the month should be chilly with a shot at some late season snow. The 1st to 5th should be showerv and cool. The 6th to 9th should be sunny and warm. The 10th to 16th should be cool and rainy. The 17th to 22nd should be sunny and cool. The 22nd to 30th aim to be cool and snowy.

The super long range forecast hints at these trends for much of 2021: May will be warmer and drier than normal. Summer will be hotter and drier than normal. Autumn will have below normal temperatures and rainfall.

the necessary amino acids. It is highly sensitive to environmental disturbances, like logging and grazing, and cannot be transplanted successfully. We have been thinning our forest this winter, so we will see whether that has had an impact on the flowers.

This makes it all the more special to us and each spring we go down the trail scanning the ground. Sometimes it is the sweet fragrance from the tiny flowers that we first notice, but most often we must get down on our hands and knees and press our noses close to the ½" wide tubular, pink blooms and inhale the delicate, exquisite scent.

Around the same time, further in the sandy soiled forest we will look for another pinkish bloom that stands above the leaf litter on hairy stems. Each blossom will have between five and 12 sepals (normally six). This is the round-

lobed hepatica. Its three leaves develop later, with a liver like shape, which led people in earlier times to believe that the plant could be used to treat diseases of the liver.

Though pink is not a color to jump out at you (except for the pink Ladyslipper, which won't be seen until late May), it is a color that stands for beauty, grace and goodness. It is a color I will seek in this month of starts and stops, an ephemeral color, just right for the flowers that wear it.

# Free tax program helps Carlton County taxpayers

Local taxpayers trying to make sense of the changing tax deadlines and guidelines can find help from the Lakes & Pines free Volunteer Income Tax Assistance (VITA) program.

And though the income tax deadline has been moved to Monday, May 17, Lakes & Pines Executive Director Bob Benes said the message to taxpayers is the same: Don't wait.

'The new tax codes provide for, hopefully, some more money in your pocket," Benes said. "You could use that now sooner rather than later. And at the end, there's going to be a rush. So get [your taxes] done early.

Benes noted that there will be some other changes this year. Due to COVID-19, there will be no in-person interaction with taxpayers. Also, as tax rules have changed, there may be more op-portunities for a larger

"If there are people who haven't in the past filed taxes, but have young children, I'd encourage them to file this time," he said. "You can't

you file, and some of the tax credits [for] children and particularly young children are pretty signif-icant in their changes this year.'

He also noted that some taxpavers may have to check to see if the latest changes to the tax code affect their refund. most notably the \$10,200 exemption for taxes for unemployment. He said those who have already filed might want to check one last time to see if they might be due a larger

#### 'THAT'S MONEY THAT COMES BACK INTO PEOPLE'S POCKETS'

Benes said the free tax filing program has two main goals. The first is to help people who may not have filed taxes in the past to do so. He said that last year they helped just short of 1,000 people, and assisted them in getting refunds of over \$1,000,000.

"And that's money that comes back into people's pockets and gets circulated into the community - whether that be paying off bills or buying products or going into financial institutions," Benes said. "It comes back into this community, and


