Rebels' qualify for Sectional championship in Esko

The Moose Lake Willow River Rebels' were ready for the playoffs, after their last game ten days ago. The first place 7AA team was given a bye in the first round of Minnesota State High School League's Sectional tournaments. It had been nearly two years since the last time the Rebels participated in a playoff game of any kind, and they took advantage of the opportunity by besting the International Falls Broncos 63-26 in Willow River.

It was Junior Jackson Thompson with the spectacular stat line, reaching the end zone four times and accumulating 167 all-purpose yards on six touches for an average of 27.8 yards per touch, with the help of the huge holes executed by the strong and quick Rebel line.

Before the start of the game, Coach Dave Louzek was honored with presentations from the Willow River School Board, Moose Lake School Board, and Minnesota State High School League for his 201 career foot-

ball victories. He is now one of the top 20 winningest coaches ever in Minnesota history. His family was on the field supporting him. He has put the area football program on the map with his influence, longevity, and dedication to the area football program. He is a genuine, positive role model, and mentor for the players/students on and off the field. His career has shaped and taught thousands of players/students preparing them for a lifetime of success.

All city positions are filled again in **Willow River**

Tiffany Parr is the new Willow River City Clerk and Art Underhill is the newest member of the Willow River City Council. These positions were vacant after sudden resignations were accepted by the council

during the October meeting. Cash will no longer be accepted in the Clerk's Office at Willow River City Hall. This is to ensure the safety of the clerk and deputy clerk and to assist in the auditing process. Cashier's check, money orders or check will still be accepted .

ZONING

The council recreated the Planning Commission in Willow River to address necessary changes to the zoning ordinances. A deadline of February was set for consideration of an interim use permit for a recently annexed property. Since the reinstatement the commission has been reviewing zoning ordinances within the city.

At this meeting the commission asked for permission from the council to continue a project to go parcel by parcel within the city to review zoning listed on the county maintained site, Beacon. The last time a zoning map for Willow River was created was in 1968, the commission plans to use this project to create an updated zoning map and then to begin reviewing further individual zoning

Masks mandated for County buildings as of Nov. 1

Masks will be mandated and the policy guidelines will go into effect on November 1 in any County owned buildings, ordered by the Carlton County Board of Commissioners at their October 25th Adjourned Session. The vote was four to one with Commissioner Mark Thell voting no and with no discussion.
Thell commented via phone,

"The infection numbers which are falling at this time do not justify masks. Community members I have talked to are not supportive of the move. I question whether a majority of the departments in County government want a mask mandate.

Health and Human Services Director Dave Lee explained that all counties in Minnesota are at a high positive rate for

COVID-19 Carlton County had an infection rate of 5.2% at a level, according to a formula of the CDC, of 228 cases per 100,000 people.

Lee explained that factors such as resumption of school attendance, more social gatherings, and people not following safety guidelines as closely as needed have increased the infection cases. Lee felt cautiously optimistic since boosters are started to be administered, children 5 to 11 are now getting vaccinated, and there is an increase of the non-vaccinated now getting their shots.

the County Board sold the Old Co-op warehouse property in Kettle River to the City of Kettle River for \$500 plus legal expenses. The Farmers Co-op Mercantile Association used the building for deliveries of coal, cement, building materials and shipped out cattle and potatoes during the existence of the Soo Line Railway. In later years, a restaurant and bar were run there after a major

remodeling. Bernu said he considers it a blighted property, and historically, properties of this type are sold at a reduced value to a government entity. At present, piles of debris are scattered in the front of the property from demolition of old camping

Carlton County government will continue with Blue Cross/ Blue Shield as a carrier for the employee health insurance. Carlton County has been a

member of the Northeast Service Cooperative and has worked with that group for health insurance coverage. The Cooperative decided to change from Blue Cross to Medica. The unions and Carlton County staff wished to stay with Blue Cross.

On recommendation from County Coordinator Dennis Genereau after support from the Insurance Committee, the County Board voted to withdraw from the Cooperative. Blue Cross/Blue Shield said they will reduce the insurance cost by 5% for the coming fiscal year and will be the carrier for 2022. The Cooperative said that Carlton County can rejoin at any time.

Pre-construction work is going on even before the Justice Center is completed and ready to use. Consultant Mike Griebel of Research Design Solutions RDS was hired to create the

policies and train the staff to run the new Justice Center in such areas as commissary, mental health intake, door controls, housing transfer, inmate release, inmate showers, perimeter security, to name a few. \$111,000 is projected for this work.

The consultant Mike Carey has been hired to handle the consultant work for the Justice Involved Female (JIF). He will develop the criteria for who will go into the program and how the program will be set up. He will work closely with RDS on the female program at a cost not to exceed \$11,250. Both the RDS and Carey contracts will come out of the \$2,000,000 grant from the State of Minnesota.

Find adventure in Lost 40 and more with help from new book

There is a stand of red pines around 230-240 years old in the Lost 40 in Northern Minnesota, said Julie Jo Larson. She wrote a book titled "100 things to do in Minnesota before you

The centuries-old trees survived due to a surveying error in 1882, according to the dnr. state.mn.us website. The trees were missed by the loggers because the surveyors mapped the area as Coddington Lake, which is actually located a half mile southeast.

The site was re-surveyed in 1960 and the area was incorporated into the Big Fork State Forest shortly after.

Larson said she has visited the area several times and is amazed each visit.

"It's so huge, three adults can't get their arms around one," Larson said. "It's pretty unbelievable when you stand next to the huge trees. We

think trees in Minnesota never grew that big, but they did."

Larson said she had a great time traveling around Minnesota hunting for hidden gems, including several closer to her Moose Lake home.

She lists Poor Gary's Wild Rice and chicken pizza as well as the jams, jellies, burgers and wild rice brats at the Buckawitz family Farm in Kettle River.

"I loved the pizza," Larson said. "It's a great play on wild rice. It's our favorite grain up

The 57-year-old is originally from New Ulm, but lived in Moose Lake 1991-2007. She moved in time to experience the great Halloween blizzard.

"I cried all winter long," Larson said. "Even DQ was closed in the winter'

She immersed herself into the community. She worked at the school, taught Sunday School and was a Boy Scout leader. She also loved being surrounded by the forests with their tall pine trees

She wrote many history stories for the Lake County Journal for several years and loved it

Although she started college in the 1980s, she graduated in 2012 after she moved to Brainerd with her family.

She began working as a social worker at the college part-time in 2016 and had every Thursday off. Each week she met with a group of friends

and they went exploring and found everything from historic buildings to cool old cemeter-

ies. "Take the time to explore

and see something different," Larson said. "So many go to the same places over and over

Larson is enthusiastic as she talks about her discoveries. One included research into the history of the Brainerd area. She discovered that while most towns in the 1800s put prostitutes in jail, the Brainerd city officials charged them a fee to operate and used the money to fund city projects.

Larson researched the book

during the pandemic and it came out April 1, 2021.

She said some people use it as a bucket list of things to do in the state, while others open to a random page and go explore whatever is on the page that weekend.

"I tried to make the book for everyone," Larson said. Larson does not have a

favorite. She said it was the people that she was with at the time that made the memory a treasure.

WATER AND SEWER

Preparations in the Public Works Department for winter are underway.

While completing a portion of line flushing this year, Water and Sew-er Operator John Mikrot noted that there was an increased amount of sand in the line. A portion of the sewer pipe also could not be televised. Further investigation showed that there was a crushed portion of pipe and then a what appeared to be a horizontal bore hole in the sewer pipe. More investigation will need to be done to understand how this happened. The pipe was approved to be repaired by the council.

OTHER NEWS

The city has received three complaints about two aggressive dogs in the last month. A review of the city dog ordinance will take place at the next council meeting. Owners of aggressive dogs receive a warning letter from the city as the first step of the ordinance, but the council was unsure what the next steps in the process of addressing the issue after the letter.

One of the reports was of a bite where blood was drawn, but was not reported to the city until weeks after the incident.

Willow River Fire Department is exploring the creation of a Fire Department Auxiliary. Members of this group would be required to have First Aid and CPR training, but would be in a supporting role for members of the Fire Department. Some possible ideas for these volunteers would be to have them make food for responding department members during large fires or to volunteer at community events. More information on the creation of this organization will come after review by the Fire Department and City



'We just want Ashley back'

Ashley is approximately 5 feet 9 inches tall and weighs about 217 pounds. She has brown/ auburn hair and her eye color is hazel.

SEARCH CONTINUES Nora said the search for her granddaughter is ongoing.

"There are leads coming in," she said. "The police are still working that area and doing ev-erything they can."

However, she made it clear that whether or not law enforcement is pursuing a criminal case, the family has only one goal.

"It's just to get Ashley, to return Ashley back, Nora said. "That is where we stand. I keep emphasizing that every time I share it. We're not looking for a conviction.





tember 24. Her family is asking for your help finding her.

That's not what we care about. People are totally safe giving any information through the private investigator. Nothing will ever be leaked. That way, it's easier for people to call. Hopefully, that will convince somebody just to talk. Maybe ... somebody will say what they need to say.

She said that the last few weeks have been difficult for all of Ashley's family and friends, but especially on Ashley's four young children.

"It was a really hard Halloween," Nora said. That was always the big thing - she'd go around with the kids. It's getting tough.

A Facebook page (www.facebook.com/ groups/381467310311521) has been set up for supporters in the search for Ashley, and

a GoFundMe (www. gofundme.com/f/ help-find-ashley-millercarlson-missing-person) has been put up as well.

Nora said that the family has found support from others who have had a loved one go missing.

"It's not a group that anybody wants to belong to, but once you get into it ... you hear stories," Nora said. "[Ashley's] not the only one miss-ing. Every day there's somebody

She said that Ashley's disappearance has left a hole in their lives that can't start healing until she is found.

"It is way too much," Nora said. "But, strong family, strong faith. We're not giving up. that's for sure. Her kids need her home.'

Chronic wasting disease testing is mandatory for opener in CWD zones

Minnesota deer hunters in several parts of the state must bring their harvested deer to sampling stations to be tested for chronic wasting disease during the opening weekends

of firearms seasons.

Mandatory testing applies to: Opening weekend of the statewide A season (Sat-

urday, Nov. 6 – Sunday, Nov. 7)

Opening weekend of the southeast-only B season (Saturday, Nov. 20-Sunday, Nov. 21).

It is part of the Minnesota Department of Natural Resources approach designed to limit the spread of the disease and keep Minnesota's wild deer healthy.

"Protecting our wild deer is a shared responsibility. Thank you to hunters who help combat CWD by submitting samples," said Barbara Keller, big game program leader. "These samples provide data

that help us better understand the prevalence of the disease in wild deer."

Hunters only need to know the number of the deer permit area (DPA) where they will be hunting to determine if CWD sampling is required.

Beyond mandatory testing, hunters also need to consider where and how their harvested deer will be processed and whether a field-dressed animal can be legally transported from the deer permit area where it is harvested.

TESTING DETAILS

The DNR conducts testing in areas where CWD has been discovered in wild or captive white-tailed deer. Depending on its proximity to known cases of CWD and whether CWD has been found in wild deer, a DPA can be designated a management, control or sur-

testing. Self-service sampling station options also will be available for hunters who would prefer to drop off their deer heads rather than having staff take the samples at stations.
DNR staff will retrieve the

heads, remove the lymph nodes and submit the tissue for sampling. Sampling stations are listed on the CWD page.

There are options for hunters who want to have their deer mounted by a taxidermist to get the deer sampled without ruining the cape of the deer. Hunters should check the CWD page for a list of cooperating taxidermists that will sample the deer for the DNR. Hunters can also cape the head themselves prior to bringing it to the sampling location, and a video showing how to cape a deer is on the DNR website

Hunters must register their deer within 48 hours of harvest and before the deer is processed—whether by phone, internet or in person. Harvest registration will not be available at CWD sampling stations.

Hunters can check for their CWD test results online at mndnr.gov/cwdcheck by en tering their nine-digit MDNR number found on licenses and site tags.

VOLUNTARY CWD TESTING

Outside of opening weekends of firearms deer seasons, voluntary submissions for deer harvested in any CWD management or control zone are being accepted at self-service stations through archery deer season, which is open through Dec. 31. Deer harvested in the surveillance zone can be sampled voluntarily by making appointments at area wildlife

Hunters not in a CWD zone can collect their own lymph node sample and submit it for testing to the Veterinary Diagnostic Laboratory at the University of Minnesota for



Agent Orange presumptives list growing

Many Veterans have gotten sick with illnesses and cancers years and even decades after coming in contact with Agent Orange while in Vietnam and other areas in the 1960s and early 1970s.

Wayne Petersdorf, 72, was in the Navy 1968-1990 as an Aircrew Survival Equipmentman. His responsibilities included inspecting, maintaining and repairing aircraft. He was stationed in the Philippines in 1972 when he was sent to work at the air base in Da Nang, Vietnam for about two weeks. He knew they were deforesting the area with Agent Orange.

"I was of the mindset that it's not going to affect me," Petersdorf said. "They're just trying to kill weeds. I was 22 years old, I wasn't worried about it"

Agent Orange was used as an herbicide to clear leaves and vegetation, according to the va.gov

Petersdorf has been blessed with good health for the majority of his life until he was diagnosed with bladder cancer in 2010. He struggled to get rid of it for three years.

Agent Orange contained a byproduct chemical called dioxin, which happens during the manufacturing process. It was later found to cause serious health issues, including birth defects and cancers.

They scraped the cancer out of my bladder and put chemo into it, Petersdorf explained. He switched from a Duluth hospital to the Twin Cities. He said the new doctor treated the cancer more aggressively. In 2013 they took out his bladder and prostate and he has

been cancer free since.
The list of accepted illnesses and cancers caused by Agent Orange are called presumptive diseases Veterans who served in certain lo-

cations were most likely exposed to the herbicide, which is referred to as presumptive exposure. Bladder cancer, hypothyroidism and Parkinson's Disease were added to the long list of presumptives in 2020.

Petersdorf filed a claim for with the VA in 2017 and was denied. Now that bladder cancer is listed as a presumptive cancer, he hopes

that will change. Vernon Cross, 77, served in the Army 1963-1983. The Pine City resident first came in contact with Agent Orange in 1968 when he was stationed in Phu Bia, which is located in the northern part of south Vietnam.

Cross said he came in contact because he shared cantonment with the 1st Cavalry Division. He explained that means his barrack was near the Cavalry's barracks on the base. The 1st Calvary Division was spraying Agent Orange at the Ho Chi Minh Trail at the time. Cross also handled the 55 gallon

drums that held the herbicide as well as helped prepare and clean the aircraft that sprayed it.

"It looked like an oilv black residue left on the outside of the aircraft after they sprayed," Cross said. They pressure washed the plane before scrubbing any remaining residue off with a brush

He said the government did not issue any safety gear or special instructions to handle Agent Orange.

Cross came in contact with the dangerous herbicide again during his second tour in 1972. He was stationed in Vung Tau, Vietnam for three months, where he was a quality control inspector for the aircraft.

In 1986 Cross was diagnosed with COPD. He said there was a Vietnamese dump near his base that was constantly burning and the smoke often floated to the base.

He filed a claim with the VA twice and was turned down both times because he smoked at the

"I have 30 percent use of my lungs," Cross said. "I'm short of breath and tired all of the time.

Last summer he was diagnosed with stage two prostate cancer. He filed a claim with the VA and was awarded compensation.

Petersdorf recommends veterans keep their original orders, pay records, training records and medical records together in a safe place. He said that was one piece of advice he took to heart when he left the military and it came in handy years later when he filed his claim. They could not find a copy of the order to send him from the Philippines to Da Nang, but he had the original safely tucked away in

his fathers Army foot locker. Veterans who have been diagnosed with any of the new presumptives can contact Pine County Services at 320-216-4250 or Carlton County Services at 218-499-6838 for more information.
