
A decision late in the day on Thursday, October 29 by the 8th Circuit United States Court of Appeals is causing a series of questions about the status and processes of mail balloting in the state of Minnesota. Due to COVID-19 large numbers of mail or absentee ballots were requested by voters in Minnesota. The court decision on Oct. 29 invalidates the earlier decision to extend the date that the state would accept mail-in ballots through Nov. 10.

Current instructions are for county and city polling places to segregate all absentee ballots received after the polls closed on Nov. 3. It is not clear if any candidate can request that ballots received after Nov. 3 at 8 p.m. be invalidated based on the court order. If one candidate on the ballot is successful at invalidating the ballot, it is not clear if the remaining candidates voted for on that ballot are also invalidated.

At present Secretary of State Simon is requesting that all precincts continue

to report ballot totals as if there has been no attempt to invalidate mail in ballots. As mail ballots arrive from Wednesday, November 4 through Tuesday, November 10 daily updates on vote totals have been requested and will be reported by the Secretary of State's office.

Carlton County COVID cases increase

Carlton County Public Health and Human Services would like to share the following message:

'Carlton County has seen a dramatic increase in COVID-19 positive cases in the past week, unfortunately setting several records. This is due in part to the MN Department of Health's new data posting of antigen test results, which are indicated as probable, along with the PCR tests posted as confirmed. MDH is treating all probable cases of COVID-19 as positive cases and get the same public health follow up and recommendations as cases confirmed by PCR. Along with the spike in cases, Carlton County also posted our second death in a resident related to COVID-19. This case was not just a statistic, this person was a member of our community; this death, and every death, hits close to home and is another sad reminder of the toll this pandemic is taking on all of us. With the increase in cases recently, we have also seen an increase in hospitalizations

related to COVID-19, with our local and regional hospitals experiencing a surge in patients. Our county case rate per 10,000 residents has also increased and will continue to increase with this current trend, which in turn affects the ability of our local schools to stay open to in-person learning models. Skilled nursing facilities are also affected by the increase in Carlton County case positivity rate as they continue to be diligent in protecting their residents at higher risk for COVID-19 complications. We can all take steps to decrease this higher level of COVD-19 transmission in our community by doing the following: · As much as possible use virtual means of communication, and digital means of ordering supplies and/or food. · Wear a mask or face covering when you are in a public setting or with people who are not in vour own household. this includes private social gatherings. • If possible limit the amount of time you spend in close proximity to people outside of your household, to less than 15 minutes. • Keep a minimum of 6 feet distance from others who are not in your household; it's okay to tell someone that you want

to keep a safer distance while interacting.

 Outdoor meetings or gatherings are safer than indoor, but could also pose a risk of COVID-19 transmission; keep your interactions brief, spaced apart, in small numbers and wear a mask.

• Clean your hands frequently with soap and water, or use alcohol-based hand sanitizer.

• If you were in close contact with someone who is positive for COVID-19, stay home and away from others for 14 days from your last contact with that person, watch for

Pine County reports first death from COVID-19 BY MIKE GAINOR

COVID-19 infections continue to rise in Pine County, and Minnesota health officials have now confirmed the first death caused by COVID-19 in Pine County.

The COVID-19 victim died on Monday, Nov. 2. Their name, gender, age and city of residence were not released by Pine County Public Health.

Pine County Public Health Director Samantha Lo issued a statement offering condolences to the family of the victim

'On behalf of Pine County, I want to extend my deepest sympathies to the family and friends who are grieving this deeply personal loss," Lo said. "Our entire community is grieving with you."

CURRENT COVID-19 STATISTICS

As of Nov. 2, 626 cases of COVID-19 have been found in Pine County this year.

A number of those cases come from correctional facilities: 182 cases come from the federal prison in Sandstone while 80 were found in the state prison in Willow River. This means 364 cases were found among Pine County community members.

Pine County Public Health believes that case counts for COVID-19 will be 30 cases per 10,000 people or higher among members of the community throughout the month of November.

The Pine County victim joins more than 237,000 victims killed by the COVID-19 coronavirus in the United States.

Medical workers and researchers have made great strides in developing treatments to keep COVID-19 patients alive. In April, six of every 100 persons found to be infected with COVID-19 died from the virus. That mortality rate has now dropped more than half, and is now roughly 2.5%.

However, this is still 25 times higher than the mortality rate (0.01%) for the seasonal flu.



- How do you stay on campus or at home and still celebrate the holidays? Have a virtual holiday celebration with your family and
 - friends. Still do all the decorating and make all the food, then show it off to your lovedones.
 - Play trivia or other games over a virtual gathering.
 - Plan a dinner with the people who live with you. If you are in a dorm and don't have access to a kitchen, check out local grocery stores or restaurants where you can order a Thanksgiving dinner for takeout.

Don't go to bars or parties with your friends unless you know that social distancing and capacity limits will be followed. Crowds and drinking have been associated with outbreaks of COVID-19.

HOW DO YOU GATHER IN-PERSON IN A WAY THAT SLOWS TRANSMISSION?

- Anyone with COVID-19 symptoms (cough, fever, shortness of breath, etc.) or who has been exposed to COVID-19 in the last 14 days should not attend - no matter what.
- Before the gathering, establish the expectation that everyone wears a mask. Consider getting your guests holiday-themed masks as a party favor and encourage everyone to wear a mask until it is time to eat.
- Keep the gathering small – the fewer, the better, but definitely no more than 10. Write down the guest list in case someone tests positive afterward.
- Arrange your furniture so it is easy for people to stay 6 feet apart.
- Choose activities that you can do while still staying far apart and wearing masks.

TRAVELING

If you are thinking about traveling away from campus or your local community during the break, it is important to take steps to slow the spread of COVID-19. Traveling can put people at greater risk of getting sick.

BEFORE YOU TRAVEL, CONSIDER:

- How much COVID-19 is spreading where you are going and how much it is spreading on campus or in your local community.
- Whether you, someone you

are traveling with, or someone you are visiting are at higher risk for severe illness from COVID-19.

- How easy or difficult it will be to keep 6 feet between people.
- Whether you would be able to miss work, school, or other activities if you get sick.
- Laying low before you go. Plan to stay at home and interact only with the people in your household for at least 14 days. If you have been exposed to COVID-19 and don't know it, this will help ensure that you don't spread it when you travel or to your loved ones when you visit.

If you decide to travel, follow these recommendations to help protect yourself and others from COVID-19:

- Take safety precautions when gathering. Limit interactions to small groups (ideally less than 5), and gather outdoors whenever possible.
- Stay 6 feet away from anyone you do not live with, and wear a mask. Wash your hands or use hand sanitizer often
- Avoid high-risk situations like crowded bars, events, parties, or other situations that would put you at risk of contracting COVID-19.
- Watch for symptoms, get tested if you develop symptoms, and stay home and away from others if you become sick.
- Minnesota does not require travelers to stay home/away from others (quarantine) for 14 days after coming back from another state. However, some colleges and universities require quarantine after travel. Learn your school's rules and protocols and plan accordingly.

Choosing grey or gray use a light therapy box which mimtry in the t

Now we have turned our clocks back an hour and for some of us, this is just additional reason to consider hibernating. The darkness comes far too soon and lasts longer each day until December 20th. It



Nature's Way Kate Crowley doesn't help that November brings gradually increasing cloud cover. It ranges from 49%- to 56% that days will be overcast or at least mostly cloudy. But today is bright and sunny and I was surprised to learn that on average November 1 is the clearest day of the month. We needed that sunshine too,

because we had cloudy or mostly cloudy (14 days) the second half of October.

If I took a box of crayons and had to pick one that represents November, I would choose gray. While some find grayness soothing and a calming contrast to all the hot reds and oranges of the previous two months, others will find themselves in a funk. This is a very real condition that has been labeled. SAD (seasonal affective disorder). It can last through the winter or until the sun is closer to our latitude. One way to deal with this problem is to use a light therapy box which mimics outdoor light. A friend has one and reports an improvement in her mood afterwards. It only requires 20-30 minutes in the morning to have an effect.

While the clouds are a big reason for my choice of grey, there are others.

In this month, even the birds and animals become part of the gray background. All of the colorful birds, except the cardinal and blue jay have flown south. The beautiful yellow American Goldfinch has replaced it feathers with grayish green ones. The other birds tend to be variations of black, white and grey. There is the Mourning Dove - an appropriate name for a bird wearing somber grey feathers, and the White Breasted Nuthatch with their slate gray backs. For a while the Dark-eyed Juncos with their solid gray bodies will hang around. But they will soon decide to head south too. The Black-capped Chickadees add some cheer by their behavior, but they too show some soft grey feathers on their sides.

Among the mammals that are still out and about, we see the white tail deer getting their much greyer winter coat - all the better to blend into the forest as hunting season begins. Of course gray squirrels will be around all winter and their bushy tails shake and shimmy as they perch near the bird feeders trying to figure out a way to get to the treasure trove.

Another grey animal that few of us ever see is the northern flying squirrel. You may think it falls into some gray area - not quite a mammal and not quite a bird. This big eyed, nocturnal animal might be mistaken for a bat, if you saw it gliding down on outstretched limbs from a branch of a tree to a feeding platform. But even though they are called flying squirrels, they are really better described as gliders, using a layer of loose skin (called the patagium) along each side of their bodies from front to back feet as a parachute of sorts. They are able to glide up to 150' and their long tail acts as both a rudder and a brake, slowing them down as they approach their landing spot.

The best way to see these winsome creatures is to put a spotlight – red if possible, on the feeder and then watch them sail in for their late evening treats. These squirrels make it through our long, cold winters like their relatives by huddling together in leafy nests.

You may have noticed that throughout this article I have sometimes written the word grey and sometimes gray. Both are correct. Written with an e is the British form and with an a is the American. I often find myself using them interchangeably. Guess it's a problem I have with my gray matter.





NOTICE OF ADOPTION OF **ORDINANCE NO. 3** BY Moose Lake and Windemere Area Sanitary Sewer District

Notice is hereby given that the Sanitary Sewer Board (the "Board") of the Moose Lake and Windemere Area Sanitary Sewer District (the "District") adopted Ordinance No. 3 entitled:

Moose Lake Windemere Area Sanitary Sewer District Ordinance No. 3 Point of Sale. New Construction and Disconnect and Reconnect Certificate of Compliance

Ordinance No. 3 is summarized below:

The Ordinance was adopted to prevent the discharge of water from roof, surface, groundwater, sump pump, footing tile, or other natural precipitation into the municipal sanitary sewer system which has the potential to cause property damage and overload the municipal sanitary sewer system.

Section 4 provides that no person shall discharge, cause to be discharged, or permit into the system any Inflow/Infiltration (I/I) or clear water because of a sump pump, defective plumbing, or a defective sewer service lateral or by any other means. Section 5 provides that any dwelling, structure or building connected, or to be connected, to the municipal sanitary sewer system that has a sump pump or other discharge system to remove ground water from its foundation drain must have a permanently installed discharge line. Section 6 provides that unless a property owner already has a valid certificate of compliance issued by the District for the property, the property owner must

complete or have completed an inspection and must obtain a certificate of compliance issued by the District prior or within 30 days of advertising an interest in real property for sale and before point of sale. Section 7 provides that any property that has applied for new construction or to disconnect and reconnect must also complete an inspection.

A certificate of compliance shall be valid for five years except that a certificate of compliance for new construction shall be valid for ten years provided that if after five years from the date of the certificate of compliance for new construction the District determines based on flow data that I/I is occurring at a property, the Board may revoke a certificate of compliance until submission of a current report for the property.

Section 7 further sets forth the requirements and procedure of the inspection, including a sump pump inspection and sewer service lateral inspection and televising. The property owner shall be responsible for all costs of the Inspection to be performed by a licensed plumber and contractor for televising. The property owner shall submit a report to the District along with the televised data specifying whether the inspection requirements have been met. If a report discloses that use of the property is not in compliance with Ordinance No. 3 or other District ordinances, policies and regulations, a correction notice will be issued by the District specifying necessary corrective actions and requiring submission of a revised report. The responsibility of repairing any nonconformance is a personal obligation of the property owner.

The Ordinance further sets forth an escrow procedure to permit the sale or transfer of property prior to receipt by the Board of a revised report and issuance of a certificate of compliance if certain conditions are met.

The Ordinance shall be effective commencing January 1,2021





- Hunters should: Buy a license.
- Know the regulations. Read up on the regulations for your deer permit area.
- Know where your deer will be processed.
- Be safe. Practice the four tenets of firearms safety, know how to set up and use the tree stand safely, wear a safety harness and wear blaze clothing.
- Take appropriate measures to prevent the spread of COVID-19. Follow precau-
