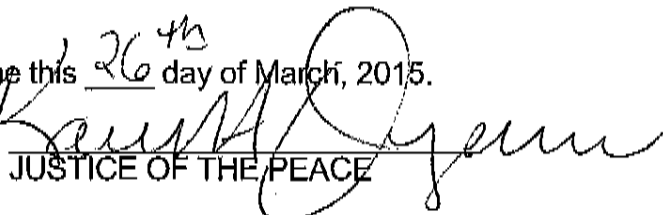
The facts constituting the offense are:

15 I have read the official law enforcement reports regarding the investigation of
16 JUSTIN GRIFFITH for allegedly committing the offense(s) set forth in the complaint and

18 to justify charging the above-named defendant as specified in the accompanying
19 complaint.

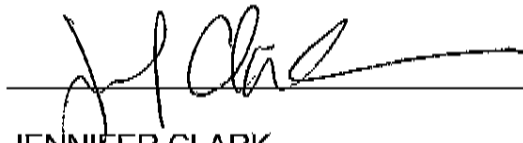
20 Justin Griffith is a clinical care worker for Western Montana Addiction Services.
21 He works night shift at the teen recovery center on Hays drive. Jane Doe, age 13, is a
22 patient there who is suffering from chemical dependency and mental health issues.

23 On March 21-23, 2015, Griffith developed a sexual relationship with Jane Doe.
24 This was reported to Jillian Henderson who is a Mental Health Counselor at the facility.
25 Jillian reported the relationship to 911. Jane Doe was taken to first step and a forensic
26 interview and examination was conducted by Nurse Cat Otway. During the interview,

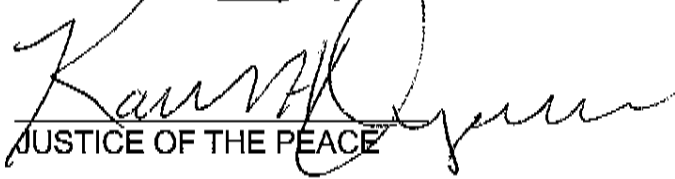
1 Jane Doe stated that she and Griffith engaged in oral sex, vaginal sex, and digital
2 penetration of her vagina.

4 Griffith admitted to having been in an intimate relationship with Jane Doe. Griffith
5 failed to go into extensive detail about the nature of the intimate relationship, but
6 admitted that it had lasted for a couple days.
