12 CHANCE CARTER, Deputy County Attorney, deposes and says that on or about
13 October 22nd, 2024, in Missoula County, the Defendant committed the offenses of:

14 COUNT I: ROBBERY, a Felony, in violation of § 45-5-401, MCA, punishable by not
15 less than 2 or more than 40 years MSP and/or \$50,000 fine;

16 COUNT II: AGGRAVATED BURGLARY, a Felony, in violation of § 45-6-204(2),
17 MCA, punishable by 40 years MSP and/or \$50,000 fine.

18 The facts constituting the offense are:

19 COUNT I: On or about October 22nd, 2024, the Defendant, while in the course of
20 committing a theft, committed the offense of robbery by inflicting bodily injury upon A.L.
21 and/or T.R.

22 COUNT II: On or about the same day, Defendant knowingly entered or remained
unlawfully in an occupied structure, to wit, the Missoula International Airport, with the

1 purpose to commit the offense of theft, and in effecting entry or in the course of
2 committing the offense, the Defendant purposely, knowingly, or negligently inflicted, or
3 attempted to inflict bodily injury upon A.L. and/or T.R.
