Narrative

While on patrol officer Shick initiated a traffic stop on an orange motorcycle bearing GA-tag YC9DGP for improper display. Upon activating his blue lights on the motorcycle, the driver accelerated at a high rate of speed. **Officer Shick then**



disengaged the traffic stop, called 10-8 on the radio, deactivated his emergency equipment, and stated the motorcycle was southbound out of the city. Prior to Mr. Leatherwood accelerating and Officer Shick disengaging the traffic stop, Officer Shick and Mr. Leatherwood were stopped at a traffic light. Mr. Leatherwood pointed to a parking lot and his rear passenger, [REDACTED] exited the bike. Shortly thereafter Officer Shick stated the motorcycle had just wrecked and called for assistance. From Officer's Shick's statement and numerous witnesses they stated the motorcycle accelerated at a high rate of speed, possibly splitting traffic or traveling through lane 1. As the motorcycle traveled through the intersection at 48th Ave South and US 17, traffic was turning left into barefoot landing (according to witnesses had green left turn signal). A white in color Dodge pick-up bearing SC-tag JHV444 pulling an aluminum john boat was turning left when the motorcycle struck the middle of the boat and trailer propelling the motorcyclist (Ed Leatherwood) through the air before coming to rest approx. 100 ft from the collision. EMS responded to the scene where Mr. Leatherwood was treated and transported to Grand Strand Hospital. SChP was notified of the collision where their MAIT Team responded and processed the scene, Trooper Colbert of the SChP completed the TR-310.

Later investigation discovered after running the VIN of the motorcycle involved in the collision it was stolen out of Alabama.
